ORDER

Consequent upon his/her selection through the Union Public Service Commission, New Delhi vide letter No. F.1/05/(01)/2021-R-III/SPC-I dated 27/03/2023, the Hon'ble Lt. Governor, National Capital Territory of Delhi is pleased to provisionally appoint **Sh./Smt. MOHD. ARSHAD KHAN (D.O.B. 04.02.1970)** to the post of Principal in Govt. Sr. Sec. School/Govt. Sec. School under the Directorate of Education, Govt. of NCT of Delhi in the in the pay scale of Level 12 (Rs. 78,800-209200) of 7th CPC of Pay Matrix plus allowances as admissible under rules on officiating basis on the terms and conditions mentioned in the offer letter already issued to him, with effect from the date of taking the charge of the said post:-

1. The above-mentioned officer will be on probation for a period of one year from the date of assumption of charge as Principal under the Directorate of Education, Delhi.
2. As recommended by UPSC, the pay scale of the candidate appointed to the post of Principal will be fixed according to the rules and instructions issued by Govt. of India, as the case may be.
3. The Provisional Appointment and drawal of pay and allowances for a period not exceeding 2 months is subject to medical examination within 2 months from the date of Provisional Appointment under provisions of FR 10 and if the candidate is Subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him/her of the findings of the medical officer/board, if no appeal for second medical examination is finally decided if such an appeal is made and accepted.
4. The provisional appointment of the above mentioned officer is further subject to subsequent verification of veracity of documents regarding Educational qualifications/experience certificate, Caste/Category/EWS/NCL/PwBD certificate and character antecedents by the concerned DDEs in a time bound manner and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, the candidature/appointment is liable to be cancelled/terminated automatically without any notice and action can be taken by the Department as per rules. In case character antecedents of the candidates are found not verified or any false information is given by the candidates, the appointment shall be cancelled forthwith any other criminal/legal action may also be taken.
5. The seniority of the above mentioned officer will be determined as per the recommendations of the UPSC and in accordance with the seniority rules and instructions issued by the Govt. of India and Govt. of NCT of Delhi from time to time.
6. The appointment of the above mentioned officer is subject to the final outcome of WP/OA No. for male candidates in WP NO. 2121/2023 & OA NOS. 1368/2021, 1394/2021, 1406/2021, 173/2023, 3724/2022, 359/2023, 392/2023 & for female candidates in WP NO. 2121/2023 & OA NOS. 1368/2021, 1394/2021, 1406/2021, 173/2023 & further subject to pending writs in HON'BLE HIGH COURT/ CENTRAL ADMINISTRATIVE TRIBUNAL.
7. The above mentioned officer is hereby directed to report to GOC branch for joining within one month of receipt of this provisional appointment order failing which his/her provisional appointment order shall be stand cancelled without any further communication.
