In continuation to the Public Notice No. F.318/DDE(IEB)/Admn.Cell/2023/7591-96 dated 27.09.2023; No. F.318/DDE(IEB)/Admn.Cell/2023/166-170 dated 10.01.2024; No. F.318/DDE (IEB)/Admn.Cell/2023/171-73 dated 10.01.2024 & No. F.318/DDE(IEB)/Admn.Cell /2023/174-76 dated 10.01.2024 regarding drawing a panel of PGT-Special Education Teacher (Guest) for Engagement in Delhi Government schools for the Academic year 2023-24 and onwards, the candidates applied for the post of PGT-Special Education Teacher (Guest) has been shortlisted on the basis of following formula:

Further, for calculation of merit, best 05 Subjects of Class Matriculation & Senior Secondary Examination have been taken into consideration whilst for B.Ed. in Special Education the marks obtained only in core subjects has been considered.

The list of the selected candidates (category wise) is given in Annexure- I. All the short listed candidates (as per Annexure- I) are directed to report to concerned HOS of the school within 05 working days, failing which it shall be presumed that candidate is not willing to join his duty and chance of deployment will be given to the next candidate in the merit list. HOS shall immediately inform IEB through mail regarding non-joining of candidates allotted within 5 days so that waitlisted candidates can be posted. The candidates are also directed to produce the following documents (in original and one self-attested photocopy) for verification by HOS:

- 1. Printout of online filled up application form 2023-24 bearing date & signature.
- 2. 10th Class Mark Sheet and Certificate showing DOB
- 3. 12th Class Mark Sheet and Certificate
- 4. B.Ed Special Education/Equivalent Qualification Mark Sheet (each year/Semester) and Degree/ Provisional Certificate
- 5. Graduation Mark Sheet (Each year/Semester wise) and Degree/Provisional Certificate
- 6. RCI Registration Certificate
- 7. CTET Certificate (Level-II) (If applied for the post of TGT-SET)
- SC/ST/OBC/EWS Caste certificate (if claiming benefits of reservation). In case of candidates belonging to OBC, the OBC certificate should be issued by Govt. of NCT Delhi.
- 9. Non creamy layer certificate for the year 2023-24 (for OBC candidates only)
- 10. Disability certificate (if applicable)
- 11. Two Photographs
- 12. Photo Identify proof (Preferably Aadhaar Card)
- 13. Present and Permanent Address proof

In addition to above, **concerned HOSs are also directed to verify the above mentioned documents with original carefully to ensure eligibility as per eligibility criteria/Recruitment Rules for the post**. The details of eligibility criteria/approved provisions of RRs of the post are given below:

1. Masters Degree from recognized university.

2. B.Ed. (Special Education)

OR

B.Ed. (General Education) with one year Diploma in Special Education or two years Diploma in Special Education or Post Graduate Professional Diploma in Special Education.

OR

B.Ed. (General Education) and Post Graduate Professional Certificate in Special Education.

OR

PG Diploma in Special Education (Mental Retardation)

OR

PG Diploma in Special Education (Multiple Disability: Physical and Neurological). OR

PG Diploma in Special Education (Locomotor Impairment and Cerebral Palsy).

OR

Secondary Level Teacher Training Course in Visual Impairment.

OR

Senior Diploma in Teaching the Deaf.

OR

BA B.Ed. in visual Impairment.

3. Registration with Rehabilitation Council of India (RCI).

Further, in case candidate is not eligible as per eligibility criteria/Recruitment Rules, he/she may not be allowed to join and his/her case shall be referred to DDE (Inclusive Education Branch) through the concerned District office. <u>The percentage of marks entered by the candidates on online application form and the percentage given in the result uploaded may vary, as best marks of 5 subjects in class 10th & 12th and in diploma/Graduation/B.ED SE and Master degree core subject have been taken for calculation of percentage in final result.</u>

However, as per instructions issued in previous Public Notice candidates who have requested for the change/correction in marks/percentage, category, name or any other details have been rectified in the final merit list based on the representation, testimonials/documents provided by the applicants. Further, these changes have been mentioned in the final merit list as well as in this order and shall be considered as final subject to production of original documents at school level.

Pending documents (if any) with regard to candidates, who have been allotted school, as per remarks given against his/her name in the circular, shall be submitted to the HOS for verification at the time of joining. Without such pending documents HOS shall not allow joining.

In addition to above, if any applicant is selected for the multiple posts then he/she will join on single post as per his/her preference and engagement on the remaining posts may stand cancelled and no request of such applicant may be entertained in this regard in future.

In case any clarification is required regarding eligibility criteria/Recruitment Rules for the concerned post then the HoS may consult and seek advice of the Section Officer, Inclusive Education Branch.

All concerned DDE (Districts) are also requested to verify the documents submitted by concerned PGT-Special Education Teacher (Guest) joined in schools under their jurisdiction as per approved provisions of RRs latest by 15.03.2024. All RDEs are requested to verify documents of 5% candidates who joined.

Further, all RDEs and DDEs are requested to lodge an FIR against the candidates whose documents are found fake/fabricated/fraud under relevant sections of IPC. Further, they may also be directed to submit a compliance report in this regard to Inclusive Education Branch latest by 15.03.2024.
