CIRCULAR

With reference to letter dated 28th August, 2023 received from the Sanskrita Bharati regarding seeking permission to conduct conversational cultural activities and various Sanskrit competitions on the occasion of Sanskrit week in all Government/Govt. Aided/Govt. Unaided Recognized Schools of Directorate of Education.

The Competent Authority has granted permission with the following terms and conditions:

- 1 The schools working should not be disrupted. The safety and security of the students should be ensured.
- 2 Financial aid will not be provided by the Directorate of Education, school (or) any student to the concerned Organization or to any person. Moreover, no foreign funding should be involved in the project without following the guidelines issued by GoI.
- 3 The privacy of students/parents should not be affected in the process of project.
- 4 The material will not show any kind of advertisement i.e. name, sign, logo, sponsorship and material should not be distributed by any Celebrity.
- 5 There shall be no uploading of the image/pictures/video of the students on social media pages expect with the prior written permission of the Director (Education).
- 6 The Organization/Researcher has to ensure that no damages occur while conducting the program. It will be the sole responsibility of the Organization and it should be rectified to the entire satisfaction of the HoS, if there is any damage.
- 7 The permission is purely provisional and liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms and conditions.
- 8 The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
- 9 Ensure that the Covid-19 protocol is being followed strictly.
- 10 The programme should be implemented under the supervision of the designated teacher(s).

Thus, all the HoSs of Government/Govt. Aided/Govt. Unaided Recognized schools of Govt. of NCT Delhi are requested to allow the representative of Sanskrita Bharati for conducting conversational cultural activities and various Sanskrit competitions on the occasion of Sanskrit week in their schools.


