**ORDER**

Whereas a tentative seniority lists of PGT male and female promoted/appointed between 01/01/2014 to 31/03/2017 were circulated vide letters No.DE.2(8)(1)/E-II/PGT(M)/2021/554 dated 03.09.2021 and No.DE.2(8)(1)/E-II/PGT(F)/2021/553 dated 03.09.2021 and objections were invited from all the Lecturers working under Directorate of Education.

And Whereas many objections were received from the teachers on the above-mentioned tentative seniority lists. The main objections of the teachers are as under:-

1. It is being claimed that their seniority No. should be fixed from the Vacancy of Recruitment Year (Date of Sending the requisition to recruiting agency) i.e. 14/02/2012 and 06/09/2013 as per DOPT'S O.M NO. 20011/1/2012-Estt(D) dated 4<sup>th</sup> March 2014.
2. Objection stating that their names should be included in the seniority list as per DOPT OM. NO. 20011/2/2019-ESTT(D) dated 13<sup>th</sup> August 2021 i.e Vacancy of Recruitment Year (Date of Sending the requisition to recruiting agency) instead of the date of declaration of final result by DSSSB.
3. Objection stating that their seniority should be fixed in the Final Seniority list already issued for the period 01/04/2010 to 31/12/2013 vide No.DE (2)(5)(29)/E-II/2014/ PGT(M)/1754-58 dated 14/03/2014 instead of 01/01/2014 to 31/03/2017 considering the recruitment year.

Whereas the provisions contained in the OM dated 04/03/2014 of DoPT, Government of India issued with reference to assignment of seniority as referred in the representations of these PGTs have been carefully considered and found that in the Para 5(i) it has been stated that "*The case of seniority already settled with reference to the application interpretation of the terms availability, as contained in DoPT O.M. dated 7.2.86/3.7.86 may not reopened*" and in the O.M. dated 13.08.2021 para 7(II) that the cases of inter se seniority has already decided in terms of O.M. No. 2001/1/1/2012-Estt (D) dated 04/03/2014 shall not be disturbed i.e. old cases are not to be reopened. Further in Para 7(III) it has been mentioned that in case of direct recruits and promotes appointed/joined during the period between 27.11.2012 and 18.11.2019 and in which case inter se seniority could not be finalized by 18.11.2019, shall also be governed by the provisions of O.M. dated 7.2.1986/3.7.1986 read with OM dated 04.03.2014, unless where a different formulation/manner of determination of seniority has been decided by any Tribunal or Court.

And whereas, from the records of the Education Department, Dte. Of Education, it has been observed that the seniority in r/o PGTs (Male and Female) holding the post as on 31.12.2013 had already been assigned and an Order has already been issued by the Competent Authority as on date 14/03/2014 i.e. even much prior to the declaration of the results of these PGTs and their joining in the Directorate of Education.

The Competent Authority has considered the representations of these PGT teachers as per the provisions/ relevant rules/guidelines/instructions of the DoPT, Govt. of India on the subject matter (specially Para 5(i) of OM Dated 04/03/2014 and 7(II) and 7(III) of the OM dated 13/08/2021 with regard to inter se seniority from time to time and has decided to **REJECT** all the representations regarding to consider assigning seniority to them as per the provisions of the DoPT, Govt. of India OM dated 04/03/2014 read with DoPT OM dated 13/08/2021 w.e.f. from the requisition year i.e. 2012 and 2013.

This issues with the approval of the Competent Authority.
