ORDER

Sub: Cancellation of Candidature for the post of TGT(Maths) Female, Post Code-37/21.

Whereas, the following candidates were nominated for the post of TGT(Maths) Female under the post code 37/21 (as per vacancy advertisement no. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide Result No. 1475 dated 29.07.2022 and their e-dossiers received from DSSSB for further proceedings of appointment. After completion of further course of documents verification on the scheduled date & time in the offer of appointment letter and Medical Examination Letter and Medical Examination thereafter, the said candidates were provisionally appointed on purely temporary basis and appointment letters were issued to them thereof (details mentioned in the list below).

And whereas, as per appointment order, the candidates were required to join their place of posting by the given date, but they did not reported. In continuation of appointment letter, final opportunity letters were issued to the said candidates through final reminder and also put in the public domain with the direction to join their duty within stipulated time mentioned in the appointment letter. The joining time has already expired therein despite of given ample time.

And Whereas, the candidate has already joined in the TGT(English)Female and no any written request/representation for extension of joining time was received by this office i.e. DoE, GNCTD in this regard. Henceforth, it is concluded that the said candidates are not interested to join the duty in TGT (Maths).

Now whereas, in accordance with the direction mentioned in the DoPT Office Memorandum No. 35016/2/93/Estt(D) dated 09.08.1995 referred para 2, wherein "An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however, within the specified period, a request is received from the candidate for extension of time."

Keeping in view of the above facts & circumstances, the appointment letters issued to her are hereby withdrawn and the candidature of the above said candidate stand cancelled, accordingly with the retrospective date of OoA. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any stage on the basis of any ground by any candidate will be entertained by the department, in future."
