CIRCULAR

Sub: To conduct CUET awareness & guidance session in the Government/Government Aided and Unaided Recognized Private Schools of South District.

Permission has been granted by the competent authority with the following terms and conditions:

1. The schools working should not be disrupted.
2. Financial aid will not be provided by the Directorate of Education School (or) Student to the concerned Organization (or) any person. Moreover, no foreign funding should be involved in the project following the guidelines issued by Gol.
3. Privacy of students/parents should not be affected in the process of project.
4. Material will not show any kind of advertisement i.e. name, sign, logo, sponsorship and material should not be distributed by any Celebrity.
5. There shall be no uploading of the image/pictures/video of the students on social media pages expect with the prior written permission of the Director (Education).
6. Organization/Researcher has to ensure that no damages occur while conducting the program. It will be the sole responsibility of the Organization and it should be rectified to the entire satisfaction of the HoS, if there is any damage.
7. The permission is purely provisional and liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms and conditions.
8. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
9. The safety and security of the students should be ensured.
10. The programme will be run under the supervision of the designated teachers.

Therefore, the HoSs of Government/Government Aided and Unaided Recognized Private Schools of South District are hereby directed to disseminate the above information among their students and to allow the representatives of D. Education Endeavor (Mr. Karan Nagpal Ph. 8700029139, 9953992593) in conducting the above awareness and guidance session in their schools.


