CIRCULAR

With reference to an e-mail dated 13.11.2023 received from the Brahma Kumari regarding seeking permission to conduct free de-addiction Awareness & Sensitization Programmes in the schools of Delhi, permission has been granted by the competent authority with the following terms and conditions:

1. The schools working should not be disrupted.
2. Financial aid will not be provided by the Directorate of Education School (or) Student to the concerned Organization (or) any person. Moreover, no foreign funding should be involved in the project without following the guidelines issued by GoI.
3. Privacy of students/parents should not be affected in the process of project.
4. Material will not show any kind of advertisement i.e. name, sign, logo, sponsorship and material should not be distributed by any Celebrity.
5. There shall be no uploading of the image/pictures/video of the students on social media pages expect with the prior written permission of the Director (Education).
6. Organization/Researcher has to ensure that no damages occur while conducting the program. It will be the sole responsibility of the Organization and it should be rectified to the entire satisfaction of the HoS, if there is any damage.
7. The permission is purely provisional and liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms and conditions.
8. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
9. The safety and security of the students should be ensured.
10. The programme will be run under the supervision of the designated teachers.

Therefore, the HoSs of all the Government schools are hereby directed to allow the Brahma Kumari teams (Ms. BK Kamala – 9818801200 – Ms. BK Meenakshi-9650057006) for conducting de-addiction Awareness & Sensitization Programmes in their schools.

Further, the HoSs of all the Government Aided and Unaided Recognized Private may allow the Brahma Kumari team for conducting this programme in their schools, if they are interested.
