ORDER

Cancellation of Candidature for the post of Assistant Teacher (Nursery)-16/19

Whereas, **Mr./Ms. RITIKA JAIN (D.O.B: 13/10/1998) ROLL NO. 12321501778, Category UR** was provisionally nominated by the DSSSB for the post of **Assistant Teacher (Nursery)** under the post code 16/19 (as per vacancy advertisement no. 03/19) by the selection mechanism authority i.e., DSSSB vide supplementary result notice No.834 dated 31.03.2022 and his/her E-dossier was received from DSSSB for further proceedings of appointment. During the course of scrutiny of documents, following deficiency was noticed:-

The candidates does not have studied HINDI subject at secondary level which is essential qualification for Assistant Teacher Nursery (16/19).

Accordingly Deficiency Memo was issued vide letter No. F.NO.DE.4(20)/DRC/E-IV/NUR(16/19)/2020/673 dated 14-06-2022 with the direction to submit the requisite documents/clarification. In response to this deficiency memo, the candidate submitted the reply stating that she has already qualified Sanskrit at secondary level and Hindi at Graduate level.


Thereafter, the case was referred to expert committee and expert committee found that the candidate dose not have essential qualification as prescribed RRs for the post of **Assistant Teacher (Nursery)**. So that, the candidate **Mr./Ms. RITIKA JAIN (D.O.B: 13/10/1998) ROLL NO. 12321501778, Category UR** is not eligible for the post of **Assistant Teacher (Nursery)**.

Keeping in view of the above facts & circumstances, the candidature of the above candidate stand cancelled accordingly. The concerned E-dossier file is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."

This issues with the prior approval of the competent Authority.


