

**Vacancy Circular**

**Sub: Proposal for filling up of 01 Existing vacant post of Chief Sports Advisor in the pay matrix level 13, in Directorate of Education, GNCT of Delhi on Deputation/absorption basis.**


Applications in the prescribed proforma (as per Annexures- I & II) are invited from eligible candidates for recruitment to 01 post of Chief Sports Advisor, Group-A, Gazetted, Non-Ministerial on deputation basis in the pay matrix Level-13, in the Education Department, Government of NCT of Delhi.

2. The Qualification/Experience and terms & conditions as mentioned in the Recruitment Rules F.8(34)/Sectt./Edn./2019/645-653, dated: 06.09.2021, are applicable. (Annexure – III)
3. Period of Deputation/ Short Term Contract shall not be more than 05 years ordinarily.
4. Maximum age limit for appointment shall not exceed Fifty Six years as on the closing date of the receipt of applications.
5. The applicants/ officers who apply for the post will not be permitted to withdraw their candidature. Subsequently, only such recommendations from their parent department, will be considered, which are accompanied by requisite personal data as per point no.7 below.
6. The term and conditions and Pay & allowances of the officers selected/ appointed on deputation/ short term contract basis, will be governed as per the provisions contained in Government of India, DoPT's OM No. 06.08.2009-Estt.(Pay.II) dated 17.06.2010, OM No.2/6/2016-Estt.(Pay-II) dated: 17.02.2016, as amended from time to time.
7. While forwarding the applications in respect of eligible applicants/ officers, the following documents must be enclosed.
  - a. Application in the prescribed pro-forma (Annexure I)
  - b. Copies of up-to-date and complete Annual Performance Appraisal Report/(APAR Dossiers) of the last five years, which should be certified by the officer not below the rank of Under Secretary.
  - c. Integrity Certificate
  - d. Vigilance Clearance including certification that no disciplinary proceeding/ Criminal Proceedings are either pending or contemplated against the applicant.
  - e. List of minor/major penalty, if any, imposed upon the applicant during last 10 years.



8. Bio-data (in three sets) and other documents of the eligible officers may be forwarded to this office through proper channel. The applications/CV not accompanied by supporting Certificates/ documents/ documents in support of qualification and experience claimed by the candidates would not be processed for determining the eligibility of the candidate for selection.
9. The applications must reach to this office, within 60 days from the date of publication in Employment News & Rojgar Samachar.
10. The crucial date of eligibility of the candidate for the appointment to the post will be the last date prescribed for receipt of application.
11. While forwarding the applications, the recommendation of the cadre controlling authority, is mandatory.

4. 1. संक्षिप्त शीर्षक एवं प्रारंभ:- (i) इन नियमों को खेल निदेशालय, मुख्य खेल सलाहकार (सा0के0से0 समूह - क, अलिपिकवर्गीय पद), भर्ती नियमावली, 2020 कहा जायेगा।

(ii) ये शासकीय राजपत्र में अपने प्रकाशन की तारीख से लागू होंगे।

2. पदों की संख्या, इनका वर्गीकरण तथा वेतन मैट्रिक्स में स्तर :- उक्त पदों की संख्या, इनका वर्गीकरण तथा वेतनमान इन नियमों के साथ संलग्न अनुसूची के कॉलम (02) से (04) में यथा विनिर्दिष्ट होंगे।

3. भर्ती पद्धति, आयु सीमा, योग्यता इत्यादि :- उक्त पदों की भर्ती पद्धति, आयु सीमा, योग्यता एवं इससे संबंधित अन्य मामले उक्त अनुसूची के कॉलम (5) से (13) में यथाविनिर्दिष्ट होंगे।



4. अयोग्यता :- वह व्यक्ति,  
(क) जिसने ऐसे व्यक्ति से जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है; या विवाह की संविदा की है;  
या  
(ख) जो एक जीवित पति/पत्नी के होते हुए किसी व्यक्ति से विवाह कर चुका है या विवाह अनुबंध कर चुका है, वह उक्त पद पर नियुक्ति का पात्र नहीं होगा।

बशर्ते यह है कि यदि राष्ट्रीय राजधानी क्षेत्र दिल्ली सरकार सन्तुष्ट है कि ऐसा विवाह ऐसे व्यक्ति एवं विवाह के अन्य पक्ष पर लागू व्यक्तिगत कानून के अंतर्गत अनुमत है और ऐसा करने के लिये अन्य आधार हैं तो वह किसी व्यक्ति को इस नियम के प्रवर्तन की छूट दे सकता है।

5. शिथिल करने की शक्ति:- जहां यदि सरकार का यह मत हो कि ऐसा करना आवश्यक अथवा समीचीन है, तो वह संघ लोक सेवा आयोग के साथ परामर्श से कारणों को लिखित में अभिलेखबद्ध करते हुए आदेश द्वारा व्यक्तियों की किसी श्रेणी या वर्ग के इन नियमों के किसी उपबंध को छूट दे सकता है।

6. बचाव:- इन नियमों के संबंध में केन्द्रीय सरकार द्वारा समय-समय पर जारी किए गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, भूतपूर्व सैनिक, अन्य पिछड़ा वर्ग एवं अन्य विशेष वर्गों के व्यक्तियों के लिये प्रदान किए जाने वाले अपेक्षित आरक्षण, आयु सीमा में छूट और अन्य रियायतों पर कोई प्रभाव नहीं पड़ेगा।

#### NOTIFICATION

Delhi, the 6th September, 2021

**No.F.8(34)/SECTT./EDN./2019/645-653:**—In exercise of the Powers conferred by provision to article 309 of the Constitution, read with Government of India, Ministry of Home Affairs Notification No. 24/78/68-DH(S) dated 24-09-1968; No.F.27/59-Him(i) dated 13<sup>th</sup> July, 1959, the Lieutenant Governor of the National Capital Territory of Delhi, hereby makes rules regulating the method of recruitment to the post of Chief Sports Advisor in the Directorate of Education, Government of National Capital Territory of Delhi as following, namely:

1. **Short title and commencement**— (i) These rules may be called the Directorate of Education, Chief Sports Advisor (GCS Group – A, Non –Ministerial Post) Recruitment Rules, 2020.

(ii) They shall come into force with effect from the date of their publication in the Official Gazette.

2. **Number of posts, its classification and Pay level in the pay matrix**—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns (02) to (04) of the Scheduled annexed to these rules.

3. **Method of recruitment, age limit, qualification, etc.** —The method of recruitment to the said post, age limit, qualification and other matters connected therewith shall be as specified in columns (5) to (13) of the said schedule.

4. **Disqualifications**—No person:

- who has entered into or contracted a marriage with a person having a spouse living; or
- who have a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Government of National Capital Territory of Delhi, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this regulation.

5. **Power to relax**—Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, in consultation with Union Public Service Commission, may relax any of the provisions of these rules with respect to any class or category of persons.

6. **Saving**—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions, required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen, Other Backward Classes and other special categories of persons in accordance with the order issued by the Central Government from time to time in this regard.
