**ORDER**

**Cancellation of offer of Appointment and candidature to the post of PGT (ENGLISH) MALE,**  
**POST Code 25/20**

Whereas, **Sh. ABHISHEK VATS, D.O.B. 21/11/1993, Roll No. 121202500222** has been nominated by the DSSSB for the post of PGT (English) Male against Post Code 25/20 vide letter No.F.4(281)/P&P/DSSSB/2019/731 dated 31.05.2022 vide Result Notice No. 858 dated 11.05.2022. Vide Offer of Appointment F.NO.DE-2(79)/DRC(E-II)/PGT(ENG)/MALE/2022/1625 dated 06.08.2022, the candidate was called for document verification and during the course of verification of documents, it was found that the candidate has completed his B.A.(English) degree for the session 2011-14 from Delhi University & another B.A. degree for the session 2011-14 from MATS University, Chattisgarh i.e. completed two degrees of B.A. from two different Universities during the same period. Consequently, vide letter no. F.NO.DE-2(79)/DRC(E-II)/PGT(ENG)/MALE/2022/1532 dated 12.08.2022 and vide letter of even no. dated 27/03/2023 and 10/04/2023 deficiency memo in this regard were issued to him. **Sh. ABHISHEK VATS** submitted replied in response to the aforesaid deficiency memorandums, which were rejected by the Competent Authority.

And, whereas, Distance Education Council, IGNOU vide letter no. F.No.DEC/Notification/40.5.1.5/2012/15983-16229 dated 01.11.2012 under subject "Policy on pursuing two or more programmes simultaneously in various combinations" has mentioned that: "A student can pursue two programmes simultaneously through distance or combination of distance and regular modes from the same or different University/Institution(s) in various combinations, viz..

1. One Degree and one Diploma/ Post Graduate Diploma/ Certificate
2. One Post Graduate Diploma and one Diploma/Certificate
3. One Diploma and one Certificate
4. Two Post Graduate Diplomas
5. Two Diplomas
6. Two Certificates."

And, whereas an Expert Committee was constituted to look into the matter of obtaining same two degrees of B.A. from different Universities during the same period. The Committee after considering all the facts in respect of the case, recommended to reject the candidature of **Sh. ABHISHEK VATS**. The recommendations of committee were placed before the Director (Education) who has accepted and has rejected/cancelled the candidature of **Sh. ABHISHEK VATS, D.O.B. 21/11/1993, Roll No. 121202500222, for the post of PGT (ENGLISH)-MALE** and his dossier returned to the DSSSB.
