
DDE (Plg.) member of Purchase Committee was on leave.

Remarks:- 01 bidder M/s R.D Excellent was found qualified in each cluster individually on the basis of technical ground whereas the firm did not meet the criteria of Cumulative Average Annual Turnover for multiple clusters as detailed in Additional Terms & Conditions.*

The Purchase Committee scrutinized/examined the informations/documents submitted by the bidders/firms corresponding to clarifications sought from them through GeM. After due deliberation, considering the clarifications/documents of following 04 bidders/firms vis-à-vis terms & conditions of the bid documents, the Purchase Committee recommended as under:-

The Committee after considering the technical bids and subsequent information/documents subsequent to queries/clarification sought as per conditions of GeM, submitted by the bidders observed that the technical bids of following bidders are found technically qualified for the clusters mentioned against them, as per terms & conditions of bid document :-

Further, the Purchase Committee observed the Order of Hon'ble High Court dated 27.07.2022 in the matter of Writ Petitions 8903/2022 & 9460/2022; wherein Hon'ble Court ordered that-

"The Respondents are permitted to proceed with the tender process. However, the Respondents shall not issue LOI without leave of the Court. The Respondents shall produce the record in respect of finalization of the tenders on the next date."

The Purchase Committee also observed the Additional Terms & Conditions (ATC) of the bid document which makes a specific provision that-

'In case a bidder is awarded contract for three clusters and is lowest in more than three clusters, the purchase committee/department shall proceed as per provisions of GFR/CVC guidelines subject to the recommendation that no bidder shall be awarded contract for more than three clusters to avoid the monopoly'.

The Purchase Committee also observed the guidelines of GeM regarding Bidding Process envisage following provisions:-

L-1 Determination from "Multiple L-1" bidders in Services:

- "Run L-1" i.e. L1 determination based on Random Algorithm run by GeM, can be executed unlimited number of times by the Buyer.
- The option to place contract on any of the L-1 bidders, manually selected by Buyer is revoked.

The Purchase Committee, keeping in the view of Order of Hon'ble High Court read with terms & conditions of ATC and guidelines of GeM for bidding process, recommended adhering with following Standard Operating Procedure (SOP) while opening of financial bids:-

Standard Operating Procedure (SOP)

- (i) In first instance, recommendation of Purchase Committee/Technical Evaluators regarding technical qualification of bidders for only 03 Clusters (A, B & C) should be updated on GeM Portal.
- (ii) Subsequently, the financial bids of only 03 Clusters (A, B & C) should be opened.
- (iii) The Directorate of Education shall seek the relaxation from Hon'ble High Court for award of contract, apprising the Court that while awarding of contracts; the Department will adhere with the guidelines of GeM. In case, multiple L-1 bidders found, the department will place the contract by selection of an agency from amongst the L-1 bidders through a Random Algorithm runs by GeM system. It should also be apprised to Hon'ble Court that Financial bids of other remaining cluster shall be opened in consequential order i.e. cluster-D to H. In case, a bidder is awarded contract for three clusters at any stage, financial bid of that concerned bidder shall not be opened in other remaining clusters. In this process, that concerned bidder shall be disqualified on technical evaluation stage referring the respective terms & conditions of ATC.
- (iv) Subsequent to relaxation from Hon'ble Court, process for awarding of contract shall be furnished through Random Algorithm runs by GeM.

The Purchase Committee recommends for opening of Financial Bids of first 03 Clusters (A, B & C) and to follow the Standard Operating Procedure (SOP) for onward opening of financial bids in other remaining Clusters (D to H) accordingly, subject to approval of the Competent Authority.
