Applications are invited by the Organizations/Firms/Agencies to collaborate with Directorate of Education, GNCTD Advt. No.F.247/DDE(IEB)/Admn.Cell/2022 dated 04.03.2023 for development of strategies for screening, identifying and providing requisite interventions for Gifted & Talented Children (**Project-ABHISHIKT**) studying in govt. schools of DOE.

Background: Gifted Students are the ones having capability to perform at higher levels as compared to others of the same age, experience, and environment in one or more domains. They exhibit high performance capability in areas such as intellectual, creativity, academics etc. and thus require services or modified activities to achieve full potential as per their capabilities.

Strategies to support Gifted Children studying in govt. schools under DoE:

- Creating Awareness and Sensitization towards Gifted Children: Understanding children with giftedness, their varied needs and catering the same, sensitization towards myths and facts about gifted children amongst Special Education Teachers (SETs), parents and other stakeholders.
- 2) Screening and Identification of Gifted Children at school level: Orientation of PGT/TGT SETs (Regular and Guest), Teachers & EVGCs for screening and identification of gifted children studying in govt. school having age 10 years and above.
- 3) Assessment and Diagnosis of Identified Children with Giftedness: IQ and aptitude test of identified students through appropriate Psychological Tools.
- 4) Planning and implementation of Interventions for Gifted Children: Formulating suitable Intervention and effective teaching strategies to equip special education teachers and class/subject teachers to provide academic and behavioural intervention to identified gifted students in Inclusive set-up.
- 5) Recognizing exceptional talent of gifted children and creating opportunities to facilitate the same by providing suitable platform.



Eligibility: Organizations/Firms/Agencies possessing atleast 03 years of experience in psychological & educational assessment, development of suitable strategies & implementation of intervention program for learners with diverse needs.
