CIRCULAR

Sub: Instructions for Organizing Workshop/ Discussion/Awareness Programme on "Importance of Education among the Community members/ Parents under "Community Mobilization."

The Project Approval Board (PAB) 2023-24 of Ministry of Education, Govt. of India considered and approved the proposal for "Activities under Community Mobilization, Major Component-RTE Entitlement at Elementary & Secondary Level under Samagra Shiksha-Delhi for the year 2023-24.

The objective of organizing Workshop/ Discussion/ Awareness Programme/ Community Meetings in 136 clusters of 13 Districts consisting of 45 members each Cluster. The objective of the workshop is to create awareness among the parents and community members regarding four major topics which includes "Importance of Education", "Benefits and facilities provided by Samagra Shiksha-Delhi to Out of School Children", "Importance of Vocational Education" and "Education provided to Children with Special Needs (Inclusive Education)"

A committee needs to be constituted at cluster level which comprises of Community leaders, Opinion makers, inclusion of active female members, active youth influencer, ASHA workers, Anganwaadi workers, SMC members.

1. DURCC and CRCC of the respective District / Cluster will organize and supervise the workshop/discussion/Awareness Programme.
2. An amount of Rs. 2025/- per cluster will be authorized at District level by Samagra Shiksha-Delhi for the purpose of arranging refreshment for 45 members Rs.45/- per person.
3. The motivational videos will be displayed and pamphlets will be distributed during the workshop by the CRCC.
