This is in references to the public notices/orders mentioned above regarding drawing a panel and engagement of Special Educator (Primary) (Guest) in Delhi Government schools for the Academic year 2023-24 and onwards. In this regard, the next waitlisted candidates applied for the post of Special Educator (Primary) has been shortlisted for engagement as Special Educator (Primary) on the basis of following formula:

Further, for calculation of merit, best 05 Subjects of Class Matriculation & Senior Secondary Examination have been taken into consideration whilst for Diploma in Special Education the marks obtained only in core subjects has been considered.

The list of the selected candidates (category wise) is given in **Annexure- I**. **All the short listed candidates (as per Annexure- I) are requested to report to concerned HOS of the school within 05 working days**, failing which it shall be presumed that candidate is not willing to join his duty. HOS shall immediately inform IEB-HQ through mail regarding non-joining of candidates allotted within 5 days so that waitlisted candidates can be posted. The candidates are also directed to produce the following documents (in original and one self-attested photocopy) for verification by HOS:

1. Printout of online filed application form bearing signature and date.
2. 10th class mark sheet and certificate showing Date of Birth.
3. 12th Class Mark sheet and certificate.
4. D.Ed Special Education or equivalent qualification Mark sheet of every year and Diploma/provisional Certificate.
5. SC/ST/OBC/EWS certificate (if applicable), issued by the Competent Authority. In case of OBC, the OBC Certificate should be issued by GNCT of Delhi.
6. Disability Certificate (if applicable).
7. Valid CTET Certificate (Paper-I)
8. RCI Registration Certificate
9. Creamy layer certificate for 2022-23 (in case of OBC candidates).



10. Two photographs
11. Photo Identity proof (Preferably Aadhar Card).
12. Address proof.

In addition to above, **concerned HOSs are also directed to carefully verify the above mentioned documents with original to ensure eligibility as per eligibility criteria/Recruitment Rules for the post.** The details of eligibility criteria/approved provisions of RRs of the post are given below:

1. XIIth passed and Two year D.Ed. Special Education in any of the category of disability.
or
XIIth passed and One year Diploma in Special Education (DSE) in any of the category of disability.
or
Diploma in Community Based Rehabilitation (DCBR) with 6 months Certificate course in Education of Children with Special Needs.
or
Post Graduate Diploma in Community Based Rehabilitation (PGDCBR) with 6 months Certificate course in Education of Children with Special Needs.
or
Diploma in Multi Rehabilitation Worker (MRW) with 6 months Certificate Course in Education of Children with Special Needs.
or
Junior Diploma in Teaching the Deaf.
or
Primary level Teacher Training course in Visual Impairment.
or
Diploma in Vocational Rehabilitation-Mental Retardation (DVR-MR)/Diploma in Vocational Training and Employment Mental Retardation (DVTE-MR) with 6 months Certificate course in Education of Children with Special Needs.
or
Diploma in Hearing Language and Speech (DHLS) with 6 months Certificate course in Education of Children with Special Needs.
or
XIIth passed with any RCI recognized qualification of minimum one year duration and 6 months Certificate course in Education of Children with Special Needs.
or
Any other equivalent qualification approved by RCI.
2. Qualified in Central Teacher Eligibility Test (CTET) (Primary stage) conducted by Central Board of Secondary Education (CBSE). Relaxation upto 5% in the qualifying marks shall be allowed to candidates belonging to reserved categories such as SC/ST/OBC/PH in CTET.
3. Registration with Rehabilitation Council of India (RCI).

Further, in case candidate is not eligible as per eligibility criteria/Recruitment Rules, he/she may not be allowed to join and his/her case shall be referred to DDE (Inclusive Education Branch) through the concerned District office. The percentage of marks entered by the candidates on online application form and the percentage given in the result uploaded may vary, as best marks of 5 subjects in class 10th & 12th and in diploma core subject have been taken for calculation of percentage in final result.



However, as per instructions issued in previous Public Notice candidates who have requested for the change/correction in marks/percentage, category, name or any other details have been rectified in the final merit list based on the representation, testimonials/documents provided by the applicants. Further, these changes have been mentioned in the final merit list as well as in this order and shall be considered as final subject to production of original documents at school level.

Pending documents (if any) with regard to candidates, who have been allotted school, as per remarks given against his/her name in the circular, shall be submitted to the HOS for verification at the time of joining. Without such pending documents HOS shall not allow joining.

In case any clarification is required regarding eligibility criteria/Recruitment Rules for the concerned post then the HOS may consult and seek advice of the Section Officer, Inclusive Education Branch.

All concerned DDE (Districts) are also requested to verify the documents submitted by concerned Special Educator (Primary) (Guest) joined in schools under their jurisdiction as per approved provisions of RRs latest by 29.02.2024. All RDEs are requested to verify documents of 5% candidates who joined.

Further, all RDEs and DDEs are requested to lodge an FIR against the candidates whose documents are found fake/fabricated/fraud under relevant sections of IPC. Further, they may also be directed to submit a compliance report in this regard to Inclusive Education Branch latest by 29.02.2024.
