ORDER
CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (HINDI) FEMALE, POST CODE-33/21

Whereas, Ms. Shashi Kiran Sharma, D.O.B -20.01.1986, ROLL NO. 112003300501 was nominated by the DSSSB for the post TGT (Hindi) Female, Post Code 33/21 (as per Vacancy Advertisement No.02/21) by the selection Mechanism Authority i.e. DSSSB, Result Notice No. 165 dated 16.08.2022 and then all the nodal formalities for appointment to the post of TGT (Hindi) Female, Post Code 33/21 were completed. Accordingly, Appointment Order was issued on 30.06.2023 to Ms. Shashi Kiran Sharma, Emp.ID-20232587 and was directed to join her duty within one month i.e. 31.07.2023.

Whereas, Ms. Shashi Kiran Sharma, Emp.ID-20232587 requested to extend the Joining period which was extended till 10.08.2023 by Competent Authority. Thereafter, she again requested to extend the Joining period which was again extended till 20.08.2023 by Competent Authority. But Ms. Shashi Kiran Sharma, Emp.ID-20232587 did not joined her duty till 20.08.2023.

In view of the above facts and circumstances, the act on the part of the aforesaid candidate is taken as refusal to accept Appointment Order for the post of TGT Hindi Female in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules.

Now whereas, the candidature in r/o Ms. Shashi Kiran Sharma, Emp.ID-20232587, D.O.B 20.01.1986 ROLL NO. 112003300501 is hereby withdrawn and her Candidature stands **Cancelled** and dossier is returned to DSSSB.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
