ORDER

Cancellation of Offer of Appointment to the post of PGT (MATHS) MALE, POST Code 28/20

Whereas, **Sh. SUMIT PRASAD**, D.O.B. **08/08/1996**, Roll No. **112002800136** has been nominated by the DSSSB for the post of PGT (Maths) Male against Post Code 28/20 vide letter no. F.4(278)/P&P/DSSSB/2019/692 dated 24.05.2022 vide Result Notice No. 855 dated 10.05.2022 and accordingly during document verification on dated 30/09/2022, some deficiencies were observed and the said candidate was advised to submit the requisite documents vide this Directorate Deficiency Memorandum No. 2574 dated 30/09/2022, the second opportunity to submit the requisite deficiency document was given to him vide reminder-I Deficiency Memorandum No. 2560 dated 07/11/2022 and Final Opportunity vide Deficiency Memorandum 2637 dated 25/11/2022.

2. And Whereas, **Sh. SUMIT PRASAD** did not gave his representation regarding the said deficiency in this Directorate issued to him vide letter of even no. dated 30/09/2022, Reminder-I of even no. dated 07/11/2022 and Final Reminder of even no. dated 25/11/2022 has neither intimated any reason to this Directorate for not responding to the deficiency memorandum.
3. As per DoPT Office Memorandum NO. 35016/2/93-Estt.(D) dated 09/08/95 wherein as per para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, In view of above, the candidature in respect of **Sh. SUMIT PRASAD**, D.O.B. **08/08/1996**, Roll No. **112002800136** is hereby cancelled and his dossier returned to the DSSSB.
