**ORDER**

**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (SST) FEMALE POST CODE-40/21**

Whereas, **KAVITA KUMARI**, DOB: **30.06.1991**, having Roll No. **318040100132**, Category- **EWS** was nominated by the DSSSB for the post TGT (Social Science) Female, Post Code 40/21 and she was called vide this Office memorandum no. : F.No.4 (43)/DSSSB/CC-IV/2021/2056-2065 dated 24.08.2022.

She has submitted an EWS certificate dated 07.02.2021 i.e. after cut off date. Therefore, this matter was kept on hold.

Whereas, she was issued a deficiency Memo dated 06.02.2023 that EWS certificate issued on 07.02.2021 submitted by her, is after the cut-off date i.e. 04.07.2021. In response to deficiency memo, she submitted an EWS certificate No. 993 dated 24.06.2021 issued by Tehsildar Syana, Distt Bulandshahr (UP) vide her reply dated 15.02.2023. The same certificate was sent to Tehsildar (Syana) Distt. Bulandshahr (UP) for verification of its contents vide letter dated 28.04.2023. Tehsildar (Syana), Distt. Bulandshahr has replied vide letter dated 15.05.2023 that EWS certificate No. 993 dated 24.06.2021 has not been issued to her. Hence, the said certificate is a forged document.

And whereas, in view of the above facts and circumstances it is concluded that the candidate is not eligible for the appointment to the post of TGT (SST) Female, Post.Code 40/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules.

Now whereas, candidature of **KAVITA KUMARI**, DOB: **30.06.1991**, having Roll No. 318040100132 stands **Cancelled** and dossier is returned to DSSSB.
