Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, **Ms. Deepika Singh, D.O.B. 20.10.1991, Roll No. 113705100029, Employee ID 20232938, Category UR,** has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi.


And whereas, **Ms. Deepika Singh** was directed to report to respective place of posting latest by **31.07.2023**. A final notice was issued by this department on 21.08.2023 to **Ms. Deepika Singh** with the directions to report to respective place of posting latest by **27.08.2023**, but as per office record, **Ms. Deepika Singh** has not joined the duty.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore, it is evident that the candidate is not willing to join the above-mentioned post of TGT (English) Female. ORDER

Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, **Ms. Hemlata Rani, DoB 16.01.1987, Roll No. 121105102452, Category OBC**, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification, following deficiencies has been found:

1. NCL for the Financial Year 2021-22, 2022-23 & 2023-24 before the cut-off date required.
2. CTET Marksheet is required.
3. 03 sets of attested Identity Certificate are required.
4. OBC certificate issued on the basis of his Brother's OBC Certificate issued from Residence of Hodal, Hasanpur, Haryana issued by Tehsildar Hodal, Haryana vide No. 643 dated 02.07.2012.

This office had issued Deficiency Memo to **Ms. Hemlata Rani** on 22.06.2023 and subsequent 03 reminders dated 11.07.2023, 26.07.2023 and 17.08.2023 to clear the deficiency. However, the deficiencies have not been removed by **Ms. Hemlata Rani** till date.

Accordingly, as the candidate has not submitted the requisite document in support of her candidature and not qualified as per the recruitment rules published in advt no. 03/21 issued by the DSSSB for the post concerned, hence, the Director of Education being the Competent Authority ordered to **cancel** the candidature of **Ms. Hemlata Rani, DoB 16.01.1987, Roll No. 121105102452, Category OBC, under Post Code 51/21** and return her dossier to the DSSSB.
