ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (HINDI) MALE, POST CODE -34/21

Whereas, Sh. Yogendra Pratap Asthana, D.O.B. 20.08.1993, Roll No.111503400161 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT HINDI(Male) post code 34/21 under UR category in Directorate of Education, Govt. of NCT of Delhi.

And whereas, on scrutiny of dossier of candidate, it was found that candidate has done B.ED Special Education instead of B.Ed. and the qualification B.Ed. Special Education is not equivalent to B.Ed. and not an eligible qualification for appointment to the post of TGT (Hindi) Male as per the provisions of RR's and other terms and conditions advertised vide no. 02/21.

And whereas, as per the advice of Legal Advisor (HQ), opinion of the Government Counsel was obtained and Government Counsel vide her letter dated 18/05/2023 has opined that:

"Since the qualification B.Ed. Special Education is not equivalent to B.Ed., the candidate cannot be appointed to the post of TGT Sanskrit and her candidature has to be rejected."

And whereas this issue has been considered in this Directorate at length but it was found that the candidate is not possessing the requisite essential qualification as per the provisions of RR's and other term and conditions required for appointment to the post of TGT (Hindi) Male.

In view of the above facts and circumstances, the appointment to the post of TGT Hindi (Male), under post code- 34/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules, is withdrawn. Now, his Candidature stands cancelled, accordingly.

This issues with the prior approval of Competent Authority.
