ORDER

REJECTION/ CANCELLATION OF CANDIDATURE IN R/O RAKESH KUMAR FOR THE POST OF TGT(HINDI) MALE UNDER POST CODE-34/21

Whereas, Sh. RAKESH KUMAR, D.O.B. 01.04.1989, Roll No.112003400092 has been provisionally nominated & selected by the DSSSB for appointment to the post of TGT HINDI (Male) post code 34/21 under OBC category in Directorate of Education, Govt. of NCT of Delhi. During the course of documents verification on the scheduled date & time given the offer of appointment letter, following deficiencies were noticed: -

1. NCL Certificate is required before cut off date.
2. Candidate has not studied Hindi Subject for 2 years in Graduation.

Whereas, deficiency memo vide dated 18.10.2022 was issued to the candidate vide which he was asked to submit clarification /requisite/deficient documents.

And whereas, in response to the deficiency memo, candidate vide his application dated 03.11.2022 has submitted clarification issued by Kirori Mal College vide letter dated 16.08.2022 stated that "he studied Hindi in Graduation Hindi Higher Qualification language course in 1st year and Hindi Discipline Course in 2nd year".

Whereas, during the scrutiny of dossier of Sh. Rakesh Kumar, it has been found that candidate has done B.A.(Hons) Political Science which is not in consonance with the provisions of RRs.

Whereas with the approval of the Director of Education the matter was referred to the expert committee to decide the eligibility of the candidate that whether he is eligible for the post of TGT (Hindi) Male, keeping in view of the qualification possess by him viz-a-viz the qualification given in the RR's.

Whereas the expert committee in the meeting held on 13.09.2023 in the chamber of Addl. DE. (School) discuss the case of Sh. Rakesh Kumar thoroughly and after the deepen observation, it was concluded that the candidate has passed B.A.(Hons.) in Political science and studied Hindi as Higher qualification language course in 1st year and Hindi discipline in 2nd year which is not in consonance with the provision of RRs which states that the B.A. degree(Honours) in one of the Modern Indian Language (MIL) concerned or B.A with MIL concerned as one of the elective subject from recognized university having 45% marks in aggregate is required. Hence, Sh. Rakesh Kumar cannot be appointed to the post of TGT (Hindi) Male under Post Code-34/21 as the candidate does not have essential educational qualification mandatorily required as per RR's.

Therefore, in view of the above facts and circumstances the candidature of Sh. RAKESH KUMAR, D.O.B. 01.04.1989, Roll No.112003400092 for the post of TGT (Hindi) Male, post code 34/21 of DSSSB advertisement vide no. 02/21 under OBC category is hereby Rejected/ Cancelled and his e-dossier returned to the DSSSB, GNCT of Delhi.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by the department, in future."

During the course of documents verification on the scheduled date & time given the offer of appointment letter, following deficiencies were noticed: -

1. 03 sets of identity certificate is required.
2. Relevant documents in respect of previous service is required for exemption (1st page of service Book with entry of Medical examination and police verification) and report of Medical examination as well as Police verification attested by Competent Authority.

Whereas, deficiency memo vide dated 01.09.2023 was issued to the candidate vide which he was asked to submit clarification /requisite/deficient documents.

And whereas, in response to the deficiency memo, the candidate has submitted the requisite documents on 13.09.2023.

Whereas, the candidate has submitted his written request vide dated 18.10.2023 that he is working in DOE as TGT (Hindi) on promotion and not interested to join the post of TGT (Hindi) Male.

Keeping in view of the above facts & circumstances, the offer of appointment issued to him is hereby withdrawn and the candidature of Sh. TEJPAL, D.O.B. 24.10.1984, ROLL NO. 112503400333 under UR category stand cancelled accordingly with retrospective date of offer of appointment, if any issued to him.
