ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (HINDI) MALE, POST CODE -34/21

Whereas, Sh. PRADEEP KUMAR, D.O.B. 25.11.1989, Roll No.112503400533 has been provisionally nominated by the DSSSB for further process of appointment to the post of TGT HINDI (Male) post code 34/21 under OBC category in Directorate of Education, Govt. of NCT of Delhi.

Whereas, on scrutiny of dossier of candidate, it was found that the marks scored in BA is 44.75% and as per Recruitment Rules, 45% marks in aggregate in B.A (Honours) in one of the Modern Indian Language (MIL) concerned or B.A with MIL concerned as one of the elective subjects from a recognized university is mandatorily required for appointment to the post of TGT(Hindi) Male.

Whereas, a deficiency memo was issued to Sh. Pradeep Kumar for submitting the requisite/ deficient documents/clarification vide letter no. DE.3(28)/DRC/E-III/TGT (HINDI)/MALE/2022/47661 dated 01.06.2023, however, in response to this deficiency memo, the candidate has failed to submit any reply/ deficient/requisite documents.

Whereas, on scrutiny and the documents available in the dossier, nothing has been found which confirmed that the candidate has passed M.A. in MIL concerned nor any documentary proof has been found in the dossier so that the relaxation in minimum percentage of marks in B.A. may be given for considering the candidate for appointment to the post of TGT(Hindi) Male.

And whereas the matter for appointment has been considered in this Directorate as per Recruitment Rules but the candidate is not found eligible for appointment for the post of TGT (Hindi) Male as the marks scored in BA is less than 45 % i.e. 44.75%.

Therefore, in view of the above facts and circumstances the candidature of Sh. PRADEEP KUMAR, D.O.B. 25.11.1989, Roll No. 112503400533 for the post of TGT (Hindi) Male, post code 34/21 of DSSSB advertisement vide no. 02/21 under OBC category is hereby Rejected/ Cancelled.

*"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."*
