ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT (SANSKRIT) FEMALE, POST CODE -55/21

Whereas, Ms. RENU BALA (DOB: 01/06/1983), having Roll No. 111905500191 was nominated by the DSSSB for the post TGT (SANSKRIT FEMALE) and she was called for document verification vide this Office memorandum no. **F.No.DE3(42)/DRC/E-III/TGT/SANSKRIT/FEMALE/2022/9874** dated 12/12/2022, to submit her acceptance against the Offer of Appointment letter.

And, as per RRs, "The candidate should have degree/diploma in teaching". Scrutiny of dossier of Ms. Renu Bala received from DSSSB revealed that the candidate pursued degree in Special B.Ed. Since the qualification B.Ed. Special Education is not equivalent to B.Ed., the candidate cannot be appointed to the post of TGT Sanskrit.

And whereas, as per the advice of Legal Advisor (HQ), opinion of the Government Counsel was obtained and Government Counsel vide her letter dated 18/05/2023 has opined that:

"Since the qualification B.Ed. Special Education is not equivalent to B.Ed., the candidate cannot be appointed to the post of TGT Sanskrit and her candidature has to be rejected."

In view of the above facts and circumstances, the appointment to the post of TGT Sanskrit (Female), under post code- 55/21 in Level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with Grade Pay of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules, is withdrawn. Now, her Candidature stands cancelled, accordingly. Candidate's E-dossier file is being sent to DSSSB for further necessary action at their end.

This issues with the prior approval of Competent Authority.
