ORDER

CANCELLATION OF CANDIDATURE FOR THE POST OF TGT(SOCIAL SCIENCE) FEMALE
POST CODE-40/21

Whereas MANISHA, D.O.B. 18.09.1993, ROLL NO. 325040101978, Category changed UR to OBC, has been nominated by the DSSSB for the post of TGT (Social Science) Female under the post code of 40/21 and she was called vide this Office memorandum No. F.No.DE.3(34)/DRC/E-III/TGT/Social Science(Female)/2022/12368 dated 10.02.2023 & its subsequent reminder to submit her acceptance against the Offer of Appointment letter. In response to this, the said candidate has reported at the given scheduled date & time of DV and has accepted the offer of appointment. The candidate has possessed two OBC certificates, one certificate Number 90500000748337 dated: 19.06.2021 issued by SDM Dwarka, GNCTD on the basis of OBC certificate issued to her Mr. Ankit brother of Ms. Manisha r/o Jhunjhunu, Rajasthan and another Certificate Number 90500001027758 dated 31.05.2023 issued by SDM Narela, GNCTD on the basis of her OBC certificate Number 66883 dated: 13.06.2002 on Delhi basis. Hence, she has uploaded OBC certificate on the basis of other state as well as she has possessed another certificate on Delhi basis submitted at the time of document verification.

And whereas, in view of the above facts and circumstances, her candidature can not be considered in OBC(Delhi) for the post of TGT (Social Science) Female, Post Code - 40/21 in level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with pay grade of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules.

Now whereas, the offer of appointment issued MANISHA, D.O.B. 18.09.1993, ROLL NO. 325040101978 is hereby withdrawn and her candidature stands cancelled and dossier is returned to DSSSB.
