**CANCELLATION OF CANDIDATURE FOR THE POST OF TGT(SOCIAL SCIENCE) FEMALE
POST CODE-40/21**

Whereas POOJA SAHANI, D.O.B. 14.07.1991, ROLL NO. 412040103355, Category OBC, has been nominated by the DSSSB for the post of TGT (Social Science) Female under the post code of 40/21 vide memorandum no. F.No.4 (43)/DSSSB/CC-IV/2021/2056-2065 dated 24.08.2022, (as per vacancy advertisement no. 02/21) by the selection mechanism Authority i.e. DSSSB vide result No 169 dated 24.08.2022. During the course of scrutiny on 12.10.2022, it was found that the candidate had submitted an OBC certificate bearing No. 9050000811881 dated 05.02.2022(after cut off date i.e. 04.07.2021) issued by Executive Magistrate, Central District, GNCTD on the basis of her father showing caste recognized in Distt. Dewarya, Uttar Pradesh vide certificate No. 902193001827 dated 22.03.2019 by Tehsildar. Hence, the said certificate has been issued after cut off date on the basis of other state.

And whereas, in view of the above facts and circumstances, her candidature can not be considered in OBC(Delhi) for the post of TGT(Social Science) Female, Post Code - 40/21 in level 7 Pay Matrix (Pre-revised Pay Band- 9300-34800 with pay grade of Rs. 4600/-) plus usual allowances as admissible under the deemed fit rules.

Now whereas, the candidature of Pooja Sahani, DOB: 14.07.1991, having Roll No. 412040103355 stands cancelled and dossier is returned to DSSSB.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
