## FINAL OPPORTUNITY MEMO

Whereas, Mr. Narendra Kumar Singh – Emp. Id. 20250844 (D.O.B: 21-07-1993), Roll No. 111503500492, a nominated candidate under 'EWS-OH-VH' category was provisionally appointed for the post of TGT (Natural Science) - Male, Post Code 35/21 vide Appointment Order No: DE.3(29)/(17)/DRC(E-III)/TGT (Natural Science)/MALE/2022/551-561 dated: 01.07.2025 (read with MIS generated Appointment Order No . DE.3(29)/(17)/DRC(E-III)/TGT (N. Sc.)/Male/2022/56 dated 26.09.2025 with Posting Id. 20250087).

Whereas, Mr. Narendra Kumar Singh (Emp. Id - 20250844) was directed to join the duties at his place of posting latest by **31.07.2025** according to the aforesaid Appointment Order dated 01.07.2025.

And whereas, Mr. Narendra Kumar Singh (Emp. Id - 20250844) did not report for duty within stipulated period i.e. 31.07.2025 at his place of posting. Further, the candidate applied vide a written application dt.29.07.2025 (received through regd. email id) for granting extension of joining time for a period of two month, and his request was considered by the Department and extension of time for joining was granted for a period of 60 days (two months) i.e. upto 30.09.2025. Further, after receiving multiple applications dated 25.09.2025, 10.10.2025 & 20.11.2025 (through regd. email id) from the candidate, extension of time for joining the duties on several times were granted by the Department and lastly upto 19.12.2025 vide Extension Order dated 12.12.2025 (vide Extension ID: 20094484), however, Candidate neither reported for duty at allotted place of posting upto 19.12.2025 nor he has represented/ requested himself through any written application by any mode with the reason as well as grant of further extension of time for joining his duties, till date. Id. 20250844- appointed provisionally for the post of TGT (Natural Science) - Male, Post Code 35/21 is hereby given the 'Final Opportunity' to join his duties at allotted place of posting latest by 30.12.2025, failing which, further necessary action will be initiated towards cancellation of his candidature for the aforesaid post without any further notice, being not willing for the aforesaid post.
