On the recommendation of the Departmental Promotion Committee held on 18.12.2025 at 03.00 pm, the Competent Authority is pleased to order the promotion of 03 Assistant Teachers (Primary) working in EDMC to the post of Domestic Science Teacher in pay scale of Rs. 9300-314800/-+ Grade Pay 4600/- (Pre-Revised) Plus usual allowances as admissible under the rules:-

The promotion of the above mentioned Assistant Teachers is subject to the following conditions:-

- (i) The promotion is further subject to vigilance clearance in terms of DoPT OM No. 22011/4/91-Estt.(A) dated 14.09.92, OM No. 22012/1/99-Estt. (D) dated 25.10.2004 and OM No. 22034/4/2012-Estt.(D) dated 02.11.2012. In case of pendency of such proceedings, the matter may be reported to this Department immediately.
- (ii) The promotion is effective from the date of assumption of charge of the post of Domestic Science Teacher by the official concerned in this Department. Monetary benefits of the promotion will accrue from the date of joining to the post of Domestic Science Teacher.
- (iii) The promotion will remain subject to outcome of the SLP ( C ) No. 031288/2017 and other connected cases before the Hon'ble Supreme Court.
- (iv) The promotion will be subject to any further clarification that may be received for DoPT, GOI and Services Departmental, Govt. of NCT of Delhi in future on the matter related to 'Reservation in promotion'.
- (v) The probation period for these teacher will be of 02 years from the date of their joining.

The Concerned Municipal Corporation Authority is requested to direct these promoted teachers to contact the Establishment-IV Branch of this Directorate at Room No. 11B Old Sectt. Delhi-110054 for submission of their willingness to join promotional post and verification of relevant documents on 26.12.2025. Any lapse in this regards will be viewed seriously.

In case, any discrepancy is noticed by Concerned Authority (i.e. MCD) in respect of to be promoted 03 teachers, the matter may be brought to the notice of E-IV Branch of this Directorate and such teacher may not be relieved till the receipt of calcification from E-IV

Branch. In case of teachers who are not found eligible for promotion as per RRs or not clear from vigilance angle, their promotion order will be cancelled.
