Mr. Rituraj Khandal, (D.O.B.-20.04.1990), Roll No. 52000071, Category-UR, a nominee of the Delhi Subordinate Service Selection Board vide letter No.F.1 (155)/P&P/DSSSB/ 2012/2963-2966 dated 29.07.2025 is hereby given an offer to a temporary post of TGT- Sanskrit (Male) in the pay scale of Rs. 9300-34800 with Grade Pay Rs. 4600/-plus usual allowances as admissible under the rules. This offer of appointment is subject to the following terms and conditions:-

- 2. That this offer of appointment is subject to successful verification of original documents in respect of educational qualification, age, category and other documents. If any discrepancy is found, this offer of appointment shall stand cancelled without assigning any reason.
- 3.
