ORDER

**REJECTION / CANCELLATION OF CANDIDATURE OF SH. DIPAK KUMAR SHUKLA FOR THE POST OF VICE PRINCIPAL**

Whereas, **Sh. Dipak Kumar Shukla** (roll No. 1105827), was provisionally nominated and selected by the Union Public Service Commission (UPSC) for further processing for appointment to the post of Vice Principal under the Directorate of Education, Govt. of NCT of Delhi, against ADVT. NO. 10/2022 (ITEM NO. 09, VACANCY NO. 22051009328) under the UR category.

And whereas, Sh. Dipak Kumar Shukla was directed for document verification vide this Office memorandum no.: No.F. 1(6)/EDN/Sectt./RPU/VP/DR/2/2020/202 dated 06.02.2024, with the request to produce all the required documents in support of his claim for the post of Vice Principal. In response, he reported for document verification on the scheduled date and the specified venue.

And whereas, during document verification, it was found that the candidate had not furnished the following requisite documents in original:

- Degree of Graduation
- Affidavit for name mismatch in B.Ed marksheet/certificate
- Certificate from NCTE for the pursuing session of B.Ed.
- Original Experience certificate
- NOC from the present employer

Accordingly, a deficiency memo was issued to him vide letter dated 12.02.2024, requesting the submission of the aforementioned deficient documents within 10 days from the issue of the letter. Subsequently, three reminders, including the final reminder, were also issued vide letters dated 03.06.2024, 26.11.2024, and 23.01.2025, requesting the submission of the aforementioned deficient documents.

And whereas, till date, the candidate has neither submitted any documents nor sought any extension for the submission of the deficient documents. Hence, it is concluded that Sh. Dipak Kumar Shukla is not willing/interested in joining the post of Vice Principal under the Directorate of Education.

And whereas, it is relevant to mention here that an offer of appointment vide No.F. 1(6)/EDN/Sectt./RPU/VP/DR/2/2020/1337-1339 dated 25.04.2024 was issued in favor of Sh. Dipak Kumar Shukla, subject to the following condition:

3. (iv) *Verification of the original certificates/degrees submitted in the UPSC.*

5. *The appointment is provisional and is subject to verification of Educational Qualification/ Experience Certificate through proper channel. If the verification reveals that the claim of educational qualification holds by candidate is false, the service of such candidate will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provision of the Indian Penal Code for production of false certificate.*

And whereas, the matter has been placed before the Hon'ble Lt. Governor of Delhi, who is the appointing authority for the post of Vice Principal, the Hon'ble Lt. Governor of Delhi has approved the cancellation of the candidature of Sh. Dipak Kumar Shukla (roll no.- 1105827) for the post of Vice Principal.

Accordingly, the candidature of Sh. Dipak Kumar Shukla (roll no.- 1105827) for the post of Vice Principal is hereby cancelled with immediate effect. The Offer of Appointment issued in favor of Sh. Dipak Kumar Shukla stands withdrawn with immediate effect.
