Whereas, Hon'ble CAT vide its judgement dated 6th August, 2025 in O.A.No. 3113/2024 has directed that: -

- (i) The impugned order dated 21/05/2024 is set aside.
- (ii) The applicant shall be entitled for all consequential benefits including reinstatement in service, arrears of back wages, continuity of service etc.

Whereas, the Hon'ble CAT orders vide O.A.nos. 2434/2024 dated14/01/2025, 2340/2024 dated 09/12/202, 2499/2024 dated 19/11/2024 and 2425/2024 dated 20/12/2024 and further the Hon'ble High Court, Delhi has also upheld the orders/directions of the Hon'ble CAT in the W.P.C.nos. 4809/2024 dated 16/04/2025, 4112/2025 dated 02/04/2025, 5326/2025 dated 25/04/2025 and 5166/2025 dated 23/04/2025 for giving appointment to the candidates whose EWS certificates are issued before the completion of the financial year i.e. between 01/01/2021 to 31/03/2021.

The order of Termination of Services of Ms.Sunaina issued vide order no.F.No.DE.3(38)/DRC/E-III/TGT (ENGLISH) /FEMALE/2022/PF-Misc.4/4378 Dated: 21/05/2024 is hereby WITHDRAWN with retrospective effect i.e. from the date of termination 21/05/2024 in accordance with the Hon'ble CAT No. O.A. No. 3113/2024. She will be entitled with all consequential benefits including re-instatement in service, arrears of back wages, continuity of service etc.
