ORDER

Cancellation of Candidature for the post of Assistant Teacher (Nursery) under post code 16/19

Whereas, Mr. **SUNIL KUMAR (Roll No: 11171500267, DOB: 17/08/1989, Selection Category: SC, Emp. ID: 20240973)** was provisionally nominated by the DSSSB vide supplementary result notice no. 911 dated 10.05.2023 for the post of Assistant Teacher (Nursery) under post code-16/19 and accordingly offer of appointment was issued to him vide Office Memorandum No. F.DE.4(20)/DRC/E-IV/Nur.(16/19)/2020/PART-I/2062 dated 07/06/2024.

And whereas, appointment cum posting order vide posting ID 20240126 dated 22/11/24 was issued to the candidate with the direction to join his duties to his place of posting latest by 23/12/2024, but he failed to join his respective place of posting within stipulated time and no extension request has been received from the candidate.

And whereas, the candidate was issued reminder vide letter no. F.DE.4(20)/DRC/E-IV/Nur.(16/19)/2020/PART-I/4107 dated 26.09.2025 and Final Opportunity vide letter dated 06.10.2025 to join the place of posting within 07 days but the candidate has still failed to join his duties on respective place of posting despite giving ample opportunities


The above act on the part of the candidate is taken as refusal to join and it is presumed that the candidate is not interested in the appointment to the post of Assistant Teacher (Nursery), under post code-16/19 in Level 6 Pay Matrix (Pre-revised Pay Scale - 9300-34800 with Grade Pay of Rs. 4200/-) plus usual allowances as admissible under the Rules.

Accordingly, the offer of appointment and provisional appointment order issued to Mr. **SUNIL KUMAR, Emp. ID: 20240973 vide Posting ID-20240126** is hereby withdrawn and the candidature stands cancelled. No further correspondence, in this regard, will be entertained by this department, in future.
