Sub:- Organization of Delhi State School Games KHO-KHO Boys and Girls 2025-26.

The stamp of the Head of the school on the Performa should be clearly visible and legible. The stamp on the photo of the student should have been affixed in such a manner that half of it should be on the photo and half on the Performa. The players will have to report in the proper playing kit.

Under 14 years	Should be born on or after 01.01.2012
Under 19 years	Should be born on or after 01.01.2007
