Subject: Postponement of Conduct of Elections for re-constitution of School Management Committees (SMCs) in Government and Government Aided Schools of Directorate of Education-Reg.

Reference: Circular No.F.23(6)/RTE/2011/60-67, dated 24.04.2025, issued from Right to Education Branch of Directorate of Education.

This is in continuation of the circular under reference cited above, vide which Guidelines for conduct of Elections for re-constitution of School Management Committees, in Govt. and Govt. Aided Schools were issued, and also to conduct Elections on 09.05.2025 for re-constitution of SMCs.

Many requests for providing adequate time period for submission of nomination applications have been received from the various stakeholders. Less number of applications have been received from Social Workers and Parents/Guardians of the students. Further, the summer vacations for the academic year will start on 10.05.2025 and many parents and students leave for their home town during this time.

Thus to make the process of re-constitution of SMCs more democratic and participative, the competent authority has decided to postpone the conduct of elections for re-constitution of SMCs, which was scheduled to be held on 09.05.2025.

Those Social Workers and the Parents/Guardians, who have already submitted their applications for inclusion in the process of re-constitution of SMCs, their applications will be considered and they need not apply afresh for the reconstitution of SMCs. It is further informed that the next schedule for conduct of elections for re-constitution of SMCs, will be announced on re-opening of schools after Summer Vacations. Meanwhile, all the schools will be functioning as usual.
