Subject: Regarding Issuance/Generation of Posting Orders through MIS for Relieving/Joining to the promotional Post of PGT (Home Science) in respect of All (Domestic Science Teachers) Promoted from the Govt. Schools of District West-A.

In pursuance of orders of E-II, Branch, Directorate of Education F.No. DE.2(2)(2)/E-II/Prom/Online posting/pt file/2024/389 dated 02.04.2026, the District Level Screening Committee was constituted by DDE (West-A) for checking/verification of original documents of 01 promoted teacher from the Govt. Schools of District West-A from the post of (Domestic Science Teacher) to the post of PGT (Home Science) as per existing RRs.

In this regard, a schedule for document verification of promoted (Home Science Teacher) was conveyed vide order NO.DE.48.13/DWA/2026/398 dated 06.03.2026.
