Cancellation of candidature to the post of PGT English (Male)
Post Code 68/23

Whereas, **Sh. Anibal Goth, (D.O.B. 27/04/1992)** (Roll No. 230681203001354) has been nominated by the DSSSB for the post of PGT English (Male) against Post Code 68/23 vide letter No. F.4(68)/ DSSSB /CC-IV/2024/913 dated: 12/09/2024 as per result notice no.247 dated 12/09/2024.


And Whereas, **Sh. Anibal Goth** neither reported in person on the scheduled date and time as given in the offer of appointment issued to him vide letter of even no. dated **02.12.2025**, reminder 1st dated **15.01.2026**, 2nd reminder dated **27.02.2026** and final reminder dated **08.04.2026** nor intimated any reason to the Directorate for not reporting and has not accepted the offer of appointment.

As per DoPT Office Memorandum NO. 35016/2/93-Estt. (D) dated 09/08/95 wherein para 2, the following has been mentioned: "An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, in view of the facts and circumstances as above and since the candidate has wilfully chosen not to responded to the memorandums dated **02.12.2025**, reminder 1st dated **15.01.2026**, reminder 2nd dated **27.02.2026** and final reminder dated **08.04.2026**, the offer of appointment and candidature in respect of **Sh. Anibal Goth** is hereby cancelled.
