**CANCELLATION OF CANDIDATURE TO THE POST OF
PGT (HOME SCIENCE) FEMALE POST CODE 816/23.**

Whereas, **Ms. Laxmi Verma (D.O.B. 27.08.1995)** (Roll No. 238161105000011) has been nominated by the DSSSB for the post of PGT (Home Science) Female under Post Code-816/23 vide letter No. F.1(829)/DSSSB/P&P-II/2024/2674-76 dated:08/07/2025 vide Result Notice No.1547 dated 20.06.2025.

And Whereas, **Ms. Laxmi Verma** did not report in person on the scheduled date and time as given in the offer of appointment issued to her vide letter of even no. dated 16.12.2025, Reminder dated 15.01.2026, Reminder-II dated 27.02.2026 and Final Reminder of even no. dated 07.04.2026. The candidate neither accepted the offer of appointment nor submitted any intimation to the Directorate of Education.

As per DoPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned:

"An Offer of Appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however, within the specified period, a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond three months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only up to a maximum period of six months from the date of issue of the original offer of an appointment". **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**

Therefore, in view of the facts and circumstances as above and since the candidate has willfully chosen not to respond to the Memorandums dated 16.12.2025, Reminder dated 15.01.2026, Reminder-II dated 27.02.2026 and Final Reminder dated 07.04.2026, the candidature in respect of **Ms. Laxmi Verma** is hereby **cancelled**.
