Consequent upon nomination through Delhi Subordinate Services Selection Board for the post of TGT-Maths(FEMALE) vide letter No.F.1 (193)/DSSSB/P&P/2013/Part file-II/I/I/1/142675/2026 Dated 13.03.2026 & Supplementary Result Notice No. 1005 dated 16.02.2026 and in compliance of order dated 28.08.2025 passed by the Hon'ble High Court of Delhi in W.P.(C) No. 13014/2023 titled GNCTD & Ors. V/s Kusum Lata & Anr and in compliance with the Ld. CAT Order dated 22.05.2023 in O.A. NO. 2920/2018. Further, with the prior approval of the Competent Authority, the candidate Ms. VEENA, is hereby appointed purely on Temporary and provisional basis, under the relaxation of FR. 10(4) for the post of TGT-Maths(Female) under the post code 09/13 Adv no. 01/2013, in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by her. The provisional appointment and draw of pay and allowance for a period not exceeding 2 months is subject to medical examination within 2months from the date of provisional appointment under provisions of FR 10 and if the candidate is subsequently found medically unfit his/her services shall be terminated after the expiry of the period of 1 month from the date of communication to him/ her of the findings of the medical officer/board. If no appeal for second medical examination is finally decided if such an appeal is made and accepted. She would also be entitled to all consequential benefits on notional basis; however, on actual basis from the date she joins the post, at par her immediate junior appointed in merit list as per the Hon'ble Court directions, if any. The candidate is directed to report to her respective place of posting by 15.07.2026, failing which her appointment will be cancelled without any prior notice. (ii) Verification of documents/certificates of qualification including caste certificate and certificate for disabled person will be done by the concerned DDE from concerned Institute/Universities/Authorities on joining the respective school. (iii) Verification of recognition of institute/university and NCTE, from which the candidate has acquired his degree and on which they rely upon for the said post. (iv) Biometric/Photograph/Manuscript Verification of the candidate. This issues with the prior approval of the Competent Authority.
