ORDER

Sub: CANCELLATION/REJECTION OF CANDIDATURE OF SHRI MOHAN AGGARWAL FOR THE POST OF TGT (SOCIAL SCIENCE) MALE, POST CODE-39/21.

Whereas, **Shri Mohan Aggarwal**, Roll No. 113303900326, DoB 30.12.1997, Category-EWS was provisionally selected vide Supplementary Result Notice No. 257 dated 05.11.2024 and e-dossiers to the post of TGT (Social Science) Male (Post Code 39/21) forwarded by DSSSB in compliance of the order of Hon'ble High Court, Delhi vide Order dated 19.07.2024 of WP© No. 2814/2024 & other similar matters & order of Ld. CAT, Delhi dated 08.08.2023 in O.A. No. 1525/2022, 1754/2022 & order dated 13.10.2023 in O.A. No. 1551/2022.

Further, the Hon'ble Lt. Governor, Delhi has accorded approval of re-consideration of the candidatures of the candidates for various teaching posts in the Education Department who submitted EWS Certificate after cut-off date, in compliance of the directions of the Hon'ble CAT, upheld by the Hon'ble High Court of Delhi and SLP filed by the Department being dismissed by the Hon'ble Supreme Court to enable the department to apprise the Hon'ble Court of the proposed course of action in the matter.

Whereas in view of the above directions of the Hon'ble Lt. Governor, Delhi and in compliance of the directions of the Hon'ble court's orders, **Shri Mohan Aggarwal** was directed to appear in person with original EWS Certificates for the 03 financial years 2019-20, 2020-21 and 2021-22 and a set of self-attested copies of the same vide Memorandum No. DE.3(33)/DRC(E-III)/TGT(Social Science)/Male/2022/EWS/81 dated 05.02.2026, Reminder No. DE.3(33)/DRC(E-III)/TGT(Social Science)/Male/2022/EWS/137 dated 26.02.2026 and DE.3(33)/DRC(E-III)/TGT(Social Science)/Male/2022/EWS/206 dated 10.03.2026.

Whereas, the Candidate has not appeared personally along with requisite documents (EWS Certificates for 2019-20, 2020-21 and 2021-22) for verification and also no reply has been received in this department from the candidate till date. However, the candidate was contacted telephonically 09.04.2026 on his mobile No. 8287003621 and he informed that he had already joined the DoE as TGT (English) on 09.09.2022 and not interested to join against the Post Code 39/21.

And whereas, the matter in detail along with relevant documents have been placed before Competent Authority and it has been approved for rejecting/cancelling the candidature of **Shri Mohan Aggarwal**, Roll No. 113303900326, DoB 30.12.1997, Category-EWS.

Therefore, keeping in view of the above facts & circumstances, candidature of **Shri Mohan Aggarwal** is hereby stand cancelled/rejected for the post of TGT (Social Science) Male, Post Code 39/21 and dossier is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate, will be entertained by the department, in future."

This issues with the prior approval of the Competent Authority.
