**CANDIDATURE CANCELLATION ORDER**

Subject: Cancellation of candidature for the post of TGT (Punjabi)F – Non-fulfillment of Essential Educational Qualification.

Whereas, the candidature of the following nominated candidates for the post of Trained Graduate Teacher (Punjabi)F, Post Code 810/24, were scrutinized with reference to the Recruitment Rules and the terms and conditions stipulated in the Advertisement Notice No.02/24.

1	HARMEET KAUR 248101212000130 30-09-1989  UR	After the deepen observation & examination of the instant matter, it was found that candidates must possess (Punjabi) as an elective subject and not an additional subject at the degree level. The Recruitment Rules specifically requires Punjabi as an elective subject forming part of the B.A. (Graduation) degree programme or studied the concerned subject during Graduation Programme (2008-2010). Instead the candidate acquired the concerned subject subsequently as an additional subject after completion of Graduation (2022-2023). The qualification of having studied Punjabi merely as an additional subject does not satisfy the prescribed requirement. In light of the established RRs it is concluded that Punjabi studied merely as an Additional Subject cannot be treated as equivalent to Punjabi studied as an Elective Subject for the purpose of determining eligibility for the post of TGT (Punjabi). Therefore, it is concluded that Ms. Harmeet Kaur cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Punjabi) under post code 810/24.
2	KAVITA DEVI 248101114000561 29-11-1993  UR	After the deepen observation & examination of the instant matter, it was found that the candidate having BCA Degree instead of any B.A.(Honours) Programme or B.A. degree with Punjabi as one of the elective Subject which is not in conformity with the prescribed RRs as essential qualification as per vacancy advertisement of the said post. In light of the established RRs for the post, it is evident that the candidate possessed BCA Degree that is not consisting the main subject as mentioned in the RR's for atleast 02 year during her Graduation course. It is concluded that Ms. Kavita Devi cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Punjabi) under post code 810/24.
3	PAYAL GARG 248101114000704 23-10-1986  UR	After the deepen observation & examination of the instant matter, it was found that the candidate having B.Sc. Degree instead of any B.A.(Honours) Programme or B.A. degree with Punjabi as one of the elective Subject which is not in conformity with the prescribed RRs as essential qualification as per vacancy advertisement of the said post. In light of the established RRs for the post, it is evident that the candidate possessed B.Sc Degree that is not consisting the main subject as mentioned in the RR's for atleast 02 year during her Graduation course. It is concluded that Ms. Payal Garg cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Punjabi) under post code 810/24.
4	AVTAR 248101114000081 14-12-1986  UR	After the deepen observation & examination of the instant matter, it was found that candidates must possess (Punjabi) as an elective subject and not an additional subject at the degree level. The Recruitment Rules specifically requires Punjabi as an elective subject forming part of the B.A. (Graduation) degree programme or studied the concerned subject during Graduation Programme (2004-2006). Instead the candidate acquired the concerned subject subsequently as an additional subject after completion of Graduation (2017-2019). In light of the established RRs it is concluded that Punjabi studied merely as an Additional Subject cannot be treated as equivalent to Punjabi studied as an Elective Subject for the purpose of determining eligibility for the post of TGT (Punjabi). Therefore, it is concluded that Ms. Avtar cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Punjabi) under post code 810/24.
5	POONAM RANI 248101212000084 14-04-1993  UR	After the deepen observation & examination of the instant matter, it was found that the candidate having B.Sc Degree instead of any B.A.(Honours) Programme or B.A. degree with Punjabi as one of the elective Subject which is not in conformity with the prescribed RRs as essential qualification as per vacancy advertisement of the said post. In light of the established RRs for the post, it is evident that the candidate possessed B.Sc Degree that is not consisting the main subject as mentioned in the RR's for atleast 02 year during her Graduation course. It is concluded that Ms. Poonam Rani cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Punjabi) under post code 810/24.

6	PROMILA DEVI 248101212000064 12.08.1994  UR	After the deep observation & examination of the instant matter, it was found that candidates must possess (Punjabi) as an elective subject and not an additional subject at the degree level. The Recruitment Rules specifically requires Punjabi as an elective subject forming part of the B.A. (Graduation) degree programme or studied the concerned subject during Graduation Programme (2012-2014). Instead the candidate acquired the concerned subject subsequently as an additional subject after completion of Graduation (2016-2017). In light of the established RRs it is concluded that Punjabi studied merely as an Additional Subject cannot be treated as equivalent to Punjabi studied as an Elective Subject for the purpose of determining eligibility for the post of TGT (Punjabi). Therefore, it is concluded that Ms. Promila Devi cannot be considered as the candidate does not have essential qualification as per set Recruitment Rule for the said post i.e. TGT (Punjabi) under post code 810/24.

And whereas, as per the prescribed essential educational qualification, a candidate must possess B.A. (Honours) in Punjabi or B.A. with Punjabi as one of the elective subjects from a recognized University, along with other prescribed qualifications.

And whereas, upon examination of the educational certificates/documents submitted/uploaded by the candidates, it has been observed that Punjabi was studied merely as an Additional Subject and not as an Elective Subject as required under the Recruitment Rules and candidates having B.Sc Degree/BCA instead of any B.A.(Honours) Programme or B.A. degree with Punjabi as one of the elective Subject which is not in conformity with the prescribed RRs as essential qualification as per vacancy advertisement of the said post.

And whereas, the matter was examined in detail by Expert Committee constituted by the higher authority for review the matter, which observed that studying Punjabi as an Additional Subject does not fulfill the essential educational qualification prescribed for the post. The Committee further noted that, in previous scrutiny processes, candidates possessing Punjabi only as an Additional Subject were consistently held ineligible for not being in conformity with the prescribed Recruitment Rules.

Now, therefore, in view of the above facts and findings, the candidature of the aforesaid candidates for the post of TGT (Punjabi)F post code 810/24 is hereby cancelled/rejected for non-fulfillment of the essential educational qualification.
