Order of Cancellation of Offer of Appointment and Candidature.

Subject: Cancellation of offer of Appointment and candidature in respect of the candidates for the post of TGT Punjabi (M) post code 810/24 Advt No.02/24 due to Non fulfilment of Essential Educational Qualifications in Graduation as per RRs (candidate studied Punjabi as Additional Subject in Graduation)

Whereas, Sh.Amarpal Singh, DoB 04.02.1993, Roll No. 248101114000775, Category UR, has been nominated by the DSSSB to the post of TGT (PUNJABI)-M in Post Code 810/24 vide Revised Result Notice No.131 No.F.4(678)/CC-1/DSSSB/2024/311-319 dated 18/02/2026 in the Directorate of Education, Govt. of NCT of Delhi and his e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification on 27/02/2026, following deficiencies have been found:

1. Candidate not studied Punjabi for atleast two years during graduation. Clarification required.


Sh.Amarpal Singh, DoB 04.02.1993, Roll No. 248101114000775, Category UR completed graduation in year 2013 and studied Punjabi as Additional Subject in year 2016.

In the same post code 810/24 in TGT (Punjabi) Female having similar cases, an Expert Committee was set up vide order DE.3(66)/DRC/E-III/TGT (Punjabi)/Misc/2025/579-582 dated 08/06/2026 for examining such cases who studied Punjabi as Additional Subject in Graduation. The Committee in its meeting held on 09/06/2026 recommended in its minutes of the meeting that "after deepen observation, it was found that candidates must possess (Punjabi) as an elective subject and not an additional subject at the degree level. The RRs specifically requires Punjabi as an elective subject forming part of the B.A.(Graduation) degree programme or studied the concerned subject during Graduation Programme. Instead the candidate acquired the concerned subject subsequently as an additional subject after completion of Graduation. The Committee, therefore, reaffirmed the established RRs that Punjabi studied merely as an Additional Subject cannot be treated as equivalent to Punjabi studied as an Elective Subject for the purpose of determining eligibility for the post of TGT (Punjabi)"

The Case of Sh.Amarpal Singh, DoB 04.02.1993, Roll No. 248101114000775 is identical and similar wherein he also has studied Punjabi as Additional Subject in the year 2016 whereas he passed his graduation in the year May, 2013. Hence, he is not eligible to the post of TGT Punjabi post code 810/24 as per the existing RRs and the recommendations of the Expert Committee in similar cases.

Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of Sh.Amarpal Singh, DoB 04.02.1993, Roll No. 248101114000775, Category UR Post TGT (PUNJABI)-Male, under post code 810/24 and return his dossier to the DSSSB.

Order of Cancellation of Offer of Appointment and Candidature.

Subject: Cancellation of offer of Appointment and candidature in respect of the candidates for the post of TGT Punjabi (M) post code 810/24 Advt No.02/24 due to Non fulfilment of Essential Educational Qualifications in Graduation as per RRs (candidate studied Punjabi as Additional Subject in Graduation)

Whereas, **Sh.Gurdass, DoB 29.12.1995, Roll No. 248101113000571, Category UR**, has been nominated by the DSSSB to the post of TGT (PUNJABI)-M in Post Code 810/24 vide Revised Result Notice No.131 No.F.4(678)/CC-I/DSSSB/2024/311-319 dated 18/02/2026 in the Directorate of Education, Govt. of NCT of Delhi and his e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification on 27/02/2026, following deficiencies have been found:

1. FIR/Court case against the candidate bearing FIR No. 692, current status required with documentary proof.
2. Punjabi subject studied in graduation as Additional Subject by the candidate

Sh.Gurdass, DoB 29.12.1995, Roll No. 248101113000571 has submitted the status of his court case in the FIR No.692.


Sh.Gurdass, DoB 29.12.1995, Roll No. 248101113000571 has studied Punjabi as Additional Subject Part -I in APRIL, 2019, Part -II in APRIL, 2019, Part -III in APRIL, 2023 whereas he passed his graduation in the year May, 2018.

In the same post code 810/24 in TGT (Punjabi) Female having similar cases, an Expert Committee was set up vide order DE.3(66)/DRC/E-III/TGT (Punjabi)/Misc/2025/579-582 dated 08/06/2026 for examining such cases who studied Punjabi as Additional Subject in Graduation. Hence, the Director (Education) being the Competent Authority ordered to cancel the candidature of Sh.Gurdass, DoB 29.12.1995, Roll No. 248101113000571, Category UR Post TGT (PUNJABI)-Male, under post code 810/24 and return his dossier to the DSSSB.
