ORDER

**REJECTION/CANCELLATION OF CANDIDATURE IN R/O SH. MOHAMMAD IBRAHEEM FOR
THE POST OF TGT URDU (MALE) UNDER POST CODE-809/24.**

Whereas, **Sh. Mohammad Ibraheem, D.O.B: 28.10.1998, Roll No. 248091114000185** was provisionally nominated & selected by the DSSSB for appointment to the post of TGT URDU (MALE) POST CODE-809/24 under UR category in Directorate of Education, Govt. of NCT of Delhi and he was called for document verification vide this office memorandum dated 16.02.2026.

And whereas, during the preliminary scrutiny of dossier of candidate, the following deficiency was found in the dossier:

- Second school subject not clear in graduation (B.A.)

And whereas, a Deficiency Memo dated 19-02-2026 was issued to candidate for submitting the requisite documents/clarification *within 15 days*. But the candidate has failed to furnish the supporting documents till date. Further, the justification/clarification submitted by the candidate vide letter dated 26.02.2026 is not upto the merit as per existing RRs.

Therefore, in view of the above facts and circumstances, the candidate does not fulfil the required eligibility criteria as per existing RRs/Advertisement No.02/2024 for the appointment to the post of TGT (Urdu) Male, Post Code 809/24.

Now whereas, the Candidature of **SH. MOHAMMAD IBRAHEEM, DOB: 28.10.1998** having Roll No. **248091114000185** is hereby withdrawn and his **Candidature stands Cancelled** and dossier is returned to DSSSB separately.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."
