This offer of appointment is subject to the following terms and conditions:-

1. That this offer of appointment is hereby issued in compliance with Supplementary Result Notice No. 1005 dated 16.02.2026 as well as the order dated 28.08.2025 passed by the Hon'ble High Court of Delhi in W.P.(C) No. 13014/2023 titled **GNCTD & Ors. V/s Kusum Lata &Anr.**
2. That this Offer of Appointment is subject to successful verification of original documents in respect of educational qualification, age, category and other documents. If any discrepancy is found, this Offer of Appointment shall stand cancelled without assigning any reason.
3. That this offer of appointment is purely on temporary basis for a period of two years which is likely to be made regular after two years on successfully completion of the probation and vitrification of (i) Date of Birth (ii) Educational Qualifications, NOC etc. (iii) Category, Status, Caste/Tribe Certificate.
4. That the Candidate would be on Probation for a period of two years which can further be extended at the discretion of the Appointing Authority.
