ORDER

Sub:- Withdrawal of Cancellation Order dated 05.03.2024 in respect of Ms. Rekha Rani (D.O.B:- 06/12/1987), Roll No.112305500108, a nominated candidate of 'EWS' category for the post of TGT (Sanskrit) Female under post code 55/21.

Whereas, Ms. Rekha Rani (D.O.B- 06.12.1987), Roll No. 112305500108, a candidate of EWS category was provisionally nominated to the post of TGT (Sanskrit) Female under post code 55/21 in 'Main Merit' of 'EWS' category by DSSSB vide Result Notice No. 167 dated 16.08.2022 in pursuance of Vacancy Notice Advertisement No.03/21 dated 12.05.2021.

Whereas, aforesaid candidate was not able to produce valid EWS Certificate issued before cutoff date, therefore, her candidature for the post of TGT (Sanskrit) Female was rejected vide Cancellation Order No. F.No. DE.3(42)/DRC/E-III/TGT (Sanskrit)/Female/2022/2929-32 dated 28/02/2024.

Whereas, Ms. Rekha Rani, aggrieved with the cancellation order dated 13/05/2024 filed in OA No 1410/2024 titled "Pooja Jha Vs Department of Education" of post code 55/21 before Hon'ble CAT. Hon'ble CAT vide order dated 21/08/2024 passed the directions to consider for appointment if found suitable on the basis of judgement dated 08.08.2023 in OA No. 1410/2024 - clubbed with OA Nos. 1525/22, 1754/22, 1356/2022 & 1360/2022). Apart this, the Hon'ble CAT also allowed another O.A. No. 1551/2022, titled "Rishikesh Sharma versus GNCTD & DSSSB" in similar matter for other post code.


Whereas, the Hon'ble Delhi High Court has upheld the orders/directions passed in the similar matters in r/o other post code(s), by the Hon'ble CAT in O.A. No. 1524/24 (in Anju & Ors. case) and 1551/2022 (in Rishikesh Sharma case), vide judgement dated 19.07.2025 in W.P.(C) 2814/2024 (filed by GNCTD & Ors. and clubbed with WPC Nos. 15889/23, 15912/23, 15953/23, 16440/23 & 16552/2023) by dismissing the filed writ petition(s) by Hon'ble High Court of Delhi. The Hon'ble Supreme Court of India has also upheld the order/judgement passed in WP (C) No. 2814/2024 vide judgement dated 04.09.2025 in SLP (C) No. 13026/2025 (filed by DSSSB & Anr.).

Whereas, the candidates were asked by the Department to attend the Office in person to submit all the documents and testimonials and specifically the original EWS certificates

for the last 03 financial years i.e. 2019-20, 2020-21 and 2021-22 alongwith one set of duly self attested documents vide Memorandum number – F.No. DE.3(29)/(39)/DRC/E-III/TGT (N. Sc.)/Male/2022/12 dated 05/02/2026. All the requisite documents were submitted on scheduled day i.e. 12.02.2026 and same are accepted by the Department. However, in CP No. 41/2025 Learned CAT has directed non – availability of the EWS certificate for the financial year 2019-20 shall not operate as a ground to deny consideration of the applicant's candidature, and the respondents shall proceed in accordance with the directions already issued by this Tribunal. Further, directed to implement the directions of this Tribunal in their true spirit and complete the process of verification of documents and consideration of the applicant's candidature expeditiously in accordance with the advertisement and the earlier order passed by this Tribunal.

Now, therefore, in compliance with the directions of the Hon'ble CAT/ Courts as aforementioned and with the approval of the Competent Authority, the Cancellation Order Order No. F.No. DE.3(42)/DRC/E-III/TGT (Sanskrit)/Female/2022/2929-32 dated 28/02/2024 is hereby withdrawn with retrospective effect of issued "Memorandum dated 17.12.2022 towards Offer of Appointment".
