PANKAJ TEWATIA (Emp. ID 20251246), (Roll No.-141502302743), D.O.B-30/11/1999, Category-UR** to join his duties till 04/03/2026 in his allotted school, but he had neither joined in aforesaid time period nor submitted any request for extension of joining .
