ORDER

Cancellation of Candidature for the post of Librarian under post code 37/22

Whereas, **Sh. Vibhanshu**, DOB: **02-11-1993**, having **Roll No.** 161401400674 **Selection Category: UR** was nominated by the DSSSB for the post Librarian, Post Code 37/22 as per vacancy advertisement no. 08/22 by the selection mechanism authority i.e., DSSSB vide result notice No. 1463 dated 05.04.2024 and E-dossier was received from DSSSB for further proceedings of appointment and after completion of further course of document verification on the scheduled date and time given in offer of appointment letter. Accordingly, the said candidate provisionally appointed under provision of FR-10 and appointment letter was issued.

Whereas as per Appointment order issued vide No. DE.4(95)/DRC(E-IV)/LIB/(37/22)/2024/VOL-1/1550-1560 dated 25-03-2025 **Sh. Vibhanshu** was required to join the place of posting by the given date,

Further, the candidate submitted a representation to extend his joining time and allowed joining extension up to 26/05/2025 and again he requested to allow joining extension up to 10/11/2025. Despite the extension in joining time **Sh. Vibhanshu** failed to join his place of posting and no representation regarding further extension of joining time was received.

In continuation of Appointment letter, Final opportunity letter was issued to the said candidate vide letter No. **F.DE.4(84)/DRC/E-IV/Misc/LIB(37/22)/2024/E-filePt.-1/4192** dated **03/11/2025** also uploaded in the public domain with the direction to join the duty within stipulated time mention in the final opportunity. The joining time has already been expired and candidate fail to join despite of given ample time.

Whereas neither **Sh. Vibhanshu** joined the duty/present physically before the competent authority nor given any written request/representation for extension of joining time was received by this office i.e. Directorate of Education, GNCTD in this regard. Hence, it is concluded that the above said candidate is not willing/interested to join the duty.

As per DoPT Office Memorandum No.35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, the following has been mentioned.

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specific period. If however within the specified period a request is received from the candidate for extension of time, it may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally."

In view of the above facts and circumstances, as stated above and since the candidate has wilfully chosen not to respond to the memorandum, this tantamount to refusal to accept offer of appointment. Therefore, the candidature in r/o **Sh. Vibhanshu**, DOB: **02-11-1993**, having **Roll No.** 161401400674 under- **UR** category is hereby cancelled and dossier is returned to DSSSB.

"No claim for appointment, if so, made at any later stage on the basis of any ground by any candidate will be entertained by the department, in future."

ORDER

Cancellation of Candidature for the post of Librarian under post code 37/22

Whereas, **Sh. Mayank Rautela (D.O.B: 25/03/1997, ROLL NO.: 161301401365, Selection Category: UR)** was provisionally nominated by the DSSSB for the post of Librarian under the post code 37/22 as per vacancy advertisement no. 08/22 by the selection mechanism authority i.e., DSSSB vide result notice No. 1463 dated 05.04.2024 and E-dossier was received from DSSSB for further proceedings of appointment.


And, whereas, Offer of Appointment was issued to **Sh. Mayank Rautela** vide memorandum dated 16/05/2025. However, Sh. Mayank Rautela remain absent for document verification. Subsequent reminders were also issued to the candidates vide letter dated 27.05.2025 and 03.11.2025 respectively.

Therefore, in view of the above facts and circumstances, since the candidate has not submitted any request/ willingness for the post of Librarian under post code 37/22 despite various opportunities, the offer of appointment in r/o **Sh. Mayank Rautela, DOB 25/03/1997, Roll No. 161301401365** is hereby withdrawn and candidature stands cancelled and, the dossier of the candidate concerned returned to the DSSSB for further necessary action at their end.
