Cancellation of Candidature for the post of Librarian under post code 92/20

Whereas, Mr. **DEEPAK KUMAR**, DOB- 13-05-1990, Roll No. **316092000279**, Selection Category-SC was nominated by DSSSB for the post of Librarian, under post code-92/20 in Directorate of Education, Govt. of NCT of Delhi vide result notice no. 888 dated 22/08/2022 and accordingly offer of appointment was issued to him/her vide No. **DE.4(42)/DRC(E-IV)/LIB/(92/20)/2022/9475 dated 07-12-2022**.

And, whereas, after document verification, Mr. **DEEPAK KUMAR**, was issued a deficiency memo vide No. F.DE.4(42)/DRC/E-IV/LIB(90/20)/2022/1219 Dated 15-12-2022 to submit one year certificate in computer application from a recognized institute. Reply submitted by him was duly examined and same was not found satisfactory according to RR's. Further the candidate was given final opportunity for submission of recognition letter of institute by Govt. of India/State Govt. /UT Govt vide memorandum no.
