ORDER

Sub: Withdrawal of Cancellation Order dated 04/03/2024 in respect of Ms. Rima Jha (DOB: 15.03.1997, Roll No. 121104216194), a nominated candidate of 'EWS' category for the post of Assistant Teacher (Primary) under post code 42/21.

Whereas, **Ms. Rima Jha (DOB: 15.03.1997, Roll No.: 121104216194)**, a candidate of EWS category was provisionally nominated to the post of Assistant Teacher (Primary) under post code 42/21 in 'Main Merit' of 'EWS' category by DSSSB vide Result Notice No. 1489 dated 02/11/2022 in pursuance of Vacancy Notice Advertisement No.02/21 dated 12.05.2021. Whereas, aforesaid candidate did not produce valid EWS Certificate issued before cutoff date, therefore, her candidature for the post of Assistant Teacher (Primary) was cancelled vide Order No. F.DE.4(60)/DRC/E-IV/PART FILE/(42/21)/PRT/2023/Pt./1190-94 dated 04/03/2024.

And whereas, **Ms. Rima Jha** filed an O.A. no **1276/2024** titled as Rima Jha v/s GNCTD & Ors in Hon'ble CAT, against the cancellation order dated 04/03/2024.


And whereas, The Hon'ble Tribunal vide its order dated 21/08/2024 disposed off OA **1276/2024** and directed the respondent "*In the light of the above, we are of the considered opinion that this OA has merit and deserves to be allowed. We accordingly quash and set aside the impugned order No.DE.4 (60)DRC(E-IV)/PART FILE/(42/21)/PRT/2023/Pt.-1190-94 dated 04.03.2024 and direct the respondents to verify the admissibility of the Income & Asset Certificate issued by SDM, Rohini within a period of 30 days and thereafter if the Certificate is found admissible as per rules and regulations on the subject, consider issuing offer of appointment to the applicant within 45 days from the date of receipt of the certified copy of this order. The applicant would be entitled to all consequential benefits like seniority and promotion on notional basis. However, there will be no payment of arrears of pay and allowances.*"

And whereas, Ms. Rima Jha was directed to submit EWS certificates for the last three financial years i.e. 2019-20, 2020-21 and 2021-22 as directed in the order passed by Hon'ble CAT in OA no. 1551/2022 dated 13/10/2023 in r/o Sh. Rishikesh Sharma considering a matter of similar nature.

And whereas, Hon'ble Tribunal has passed judgment in Contempt Petition dated 11.03.2026 in OA No 1276/2024 titled as Rima Jha v/s GNCTD & Ors and directed the respondent that "*it is now clarified that non availability of the EWS certificate for the three above mentioned financial years shall not operate as a ground to deny consideration after applicants' candidature, and the respondents shall proceed in accordance with the directions already issued by this Tribunal*"


Now, therefore, in compliance of the directions of the Hon'ble Tribunal as mentioned above and with the approval of the Competent Authority, the Cancellation Order No. F.DE.4(60)/DRC/E-IV/PART FILE/(42/21)/PRT/2023/Pt./1190-94 dated 04/03/2024 in r/o **Ms. Rima Jha**, is hereby withdrawn with retrospective effect.
