CIRCULAR

Subject: Completion of Pending Student Progression Activity in the UDISE+ Portal for the Academic Year 2025-26 and Completion of work of UDISE+ for the year 2026-27.

It has been observed that a large number of schools across the country are yet to complete the Student Progression Activity in the UDISE+ Portal. The delay in completing this activity is preventing students from being properly enrolled in schools despite their physical admission. In cases where students have migrated from one State/UT to another, the destination school is unable to import the student's record into the UDISE+ Portal until the progression activity is completed by the previous school. This adversely affects the admission and enrolment process of such students.

In view of the above, all Heads of Schools of all Management (DOE, MCD, NDMC DCB and Jamia) are hereby directed to:

1. Complete the **Student Progression Activity** in the UDISE+ Portal for all eligible students without any delay.
2. Verify that the progression status of every student has been updated correctly before final submission.
3. Ensure that no eligible student remains pending due to incomplete or incorrect data.
4. Complete the entire Student Progression Activity **on or before 31.07.2026**, without fail.
5. All UDISE+ related work should be completed **on or before 31.08.2026**.

Heads of Schools shall personally monitor the progress and ensure timely completion of the activity. Any delay or negligence in completing the Student Progression Activity may adversely affect students' enrolment and migration in the UDISE+ Portal.

In addition, the Director of Education (NDMC), Director of Education (MCD), Chief Executive Officer, Delhi Cantonment Board, all Deputy Directors of Education (DDEs)/District Project Officers (DPOs) of the Directorate of Education, District UDISE+ Coordinators, and all concerned officials are requested to closely monitor the progress of schools under their respective jurisdictions and ensure **100% completion of the Student Progression Activity within the prescribed timeline.**

This may be treated as **MOST URGENT.**
