CIRCULAR

Sub:- Operationalization of the scheme "Mukhyamantri Khel Prothsahan Yojana" – Training Support, Participation Support & Achievement Recognition.

With an aim to create a player-centric ecosystem to promote sports, the Government of NCT of Delhi has launched the "Mukhyamantri Khel Prothsahan Yojana" which envisions to support the sportspersons not just for their training requirement, but also help them participate in international tournaments besides rewarding their achievements in various sporting events by way of cash incentives.

Applications are invited from eligible & desirous sportspersons under the training support and achievement recognition part of the Mukhyamantri Khel Prothsahan Yojana for the year 2024-25 as per details below: -

1. **GAMES TO BE PROMOTED:-** Games as per list at Annexure 1 will be considered for training support to School Sportspersons and Games as per list at Annexure 2 will be considered for providing training support to elite sportspersons.
2. **CRITERIA FOR SELECTION:**
 - i. **Training support for school student**
 - (a) He/she should figure in the top 8 Delhi State ranking/rating in individual sports as on 31 December of a previous calendar year, in his/her respective age category maintained by respective Delhi State Sports Federations in the immediate previous calendar year in respective age categories in the listed games and (ii) he/she is from Delhi School.
 - (b) for team games / sports, if (i) he/she is a member of District/Zonal team which has reached in the semi-final of the identified State championships /State tournaments/ State games; and (ii) he/she is from Delhi School and has been selected in the Delhi State team to represent the state in identified national championships/tournaments in the immediate previous year.
 - (c) Explanation: A sportsperson in order to apply for benefits under this scheme in the year 2025-26 will be eligible if he/she figures in the top 8 Delhi State ranking/rating in individual sports as per point a or as per point b for team games in the year 2024-25.



ii. **Training support for Elite Athletes**

- a. He/she should figure in the top 8 national ranking/rating in individual sports as on 31 December of a previous calendar year, in his/her respective age category, maintained by respective National Sports Federations in the immediate previous calendar year:
- b. for team games / sports, if (i) he/she is a member of Delhi State team who has reached in the semi-final of the identified national championships / national tournaments/national games; and (ii) he/she is from Delhi and has been selected in the Indian team to represent the country in identified international championships/tournaments in the immediate previous year.
- c. Explanation: A sportsperson in order to apply for benefits under this scheme in the year 2025-26 will be eligible if he/she figures in the top 8 national ranking/rating in individual sports as per point a or as per point b for team games in the year 2024-25.

iii. **Achievement Recognition**

- (a) All sports disciplines which are organized by the sports federations recognized by Government of India or Indian Olympic Association in the year 2024-25 will be considered for cash incentive at the state and national level and for international events by sports federations/associations recognized/affiliated by the International Olympic Committee.
- (b) No cash incentive will be given for Ranking Tournaments, Federation Cup and Open National tournaments.
- (c) The reward for coach will be determined exclusively on the declaration of the sportsperson, in the form of an affidavit, whom he / she would have trained.
- (d) No cash incentive will be provided in those event / events of international championships / tournaments, where there are less than five participants from different countries.
- (e) A player will be provided incentive separately for all positions (Gold, Silver & Bronze medals) obtained by him/her in international tournaments.
- (f) A player will be provided incentive only for one national event in case of National achievements e.g. if a player has won medals in National Games, National Championships, National School Games etc., then he/she will be provided incentive only for one National event where he/she has got highest amount.
- (g) Cash incentive on account of National achievements will be disbursed to those players only, who have represented Delhi State in national championships.



- (h) A financial year will be taken for determining the eligibility of a player.
- (i) The category of High Priority, Priority & Other Games will be considered as per the list of Govt. of India, Ministry of Youth Affairs and Sports in the year the tournaments were held.
- (j) Cash incentive for State and National achievement will not be given simultaneously, event carrying higher amount will be considered for the scheme.
- (k) A player will be provided incentive only once in a year for all his/her international as well as national achievements.

3. **AGE LIMIT:** There will be no age limit.

4. **ESSENTIAL CONDITION;**

(i) The player should be a bonafide resident of Delhi for the last 3 years and/or regular student of any school situated in Delhi for past 3 years;

OR

(ii) He/She should have represented Delhi in National tournaments and championship in any of the last 2 years, immediately preceding from the time of request for assistance is made

OR

(iii) He/She should be enrolled for past 2 years/ passed out from Delhi schools.

OR

(iv) If he/she is enrolled as a regular student in any University situated at Delhi but is not a bonafide resident of Delhi and satisfies any of the following two conditions at the time of enrolment in university, provided he will represent Delhi in future tournaments/competitions:

(a) he/she figures in the top 8 national ranking/rating in individual sports of a particular calendar year, in his/her respective age category, maintained by respective National Sports Federations in the previous calendar year,

(b) he/she has represented his/her respective State in team games at National level in the previous calendar year, in their respective age categories and has shown extraordinary performance & played key role in the performance of the team

OR

(v) If he/she has passed out as a regular student from any university situated at Delhi and shifted to any other State/UT for higher studies or employment but continues to represent Delhi in sports competitions



5. **OBLIGATIONS OF THE PLAYER:**

(i) A sportsperson, selected under this scheme, has to represent Delhi in all competitions where he/ she intends to participate during the time period of assistance.

(ii) A sportsperson, selected under this scheme, may be engaged as Brand Ambassador of Delhi by Govt. of NCT of Delhi and his/her image may be used in sports promotion/ advertisements of Government of NCT of Delhi without any additional remuneration.

(iii) A sportsperson, selected under this scheme, will give preference to Delhi for coaching budding and talented sportspersons, in future. He/she will be paid suitable remuneration for this work, as may be decided by the Directorate of Education, in consultation with the COE being constituted under this scheme.

(iv) The image of a sportsperson selected under this scheme may be used for any welfare measure or promotional campaigns including sports development and promotion, by the Government of NCT of Delhi for which no additional remuneration will be paid.

(v) A contract in this regard will be made with the sportsperson by Govt of NCT of Delhi only after written consent and prior to disbursement of his/her assistance.

6. **FINANCIAL SUPPORT**

1. A sportsperson will be supported for his needs related to food / nutrition, sports equipment, sports kits, training and travel, boarding & lodging within the country (School students) as well as outside the country (Elite Sportspersons) and medical need. The quantum of support will be demand linked but not exceeding Rs. 5.00 lakh for school students and up to Rs. 20.00 lakhs for elite athletes per year under the **Training Support**.
2. The whole amount for Training Support will not be disbursed in one instalment. In the first instance only 60% of the recommended amount will be disbursed for which the athlete will submit utilization certificate, bills, vouchers etc. Thereafter, the remaining amount will be disbursed. If the COE recommends continuation of assistance for the next year, then the utilization for the remaining amount will have to be submitted before release of the funds.
3. However, in the case of achievement recognition the entire amount will be disbursed in 1 instalment directly to bank account.



7. OTHER SUPPORT

Medical assistance will be covered by medical insurance. Maximum insurance coverage will be Rs. 5.0 Lakh for School students and Rs. 10 lakhs for Elite athletes under **the Training Support** in each case. In addition, risk of accident will also be covered for the same amount for which the incremental premium is expected to be very minimal. The insurance premium will be paid for each beneficiary by the Government within the ceiling of Rs 5.0/20.00 lakhs envisaged in the scheme for each sportsperson. For this purpose, the Department will identify the insurance agency following due codal formality. Additionally, the department will also associate with Safdarjung Sports Injuries Centre / Indian Spinal Injuries Centre or any other reputed institution working in the field of Sports Medicine and Sports Injury for sports medicine support for needy players.

8. TIME PERIOD FOR THE PLAYERS:

Players will be supported initially for 1 year. The continuation of support will be reviewed by the Committee of Experts, initially after one year and thereafter every 6 months, on the basis of performance during the period of support.

9. PERFORMANCE CRITERIA:

1. During the period of support of one year, the sportsperson will have to compete in the highest international or national tournament falling in that period. His/her performance will be assessed by the CoE during the period of assistance by the government. If his/her performance declines as compared to his/her previous performance, and falls below the 'criteria of selection' then the support will be withdrawn. The name of international tournaments and national games etc. will be suggested by Committee of Experts and approved by Directorate of Education.
2. In case the support of the athlete is withdrawn on review by the Committee, an equivalent number of candidates in the same sports, meeting the selection criteria, will be enrolled in the scheme after inviting online applications.

10. GENERAL INFORMATION:


1. In case of any dispute or interpretation of the scheme, the decision of the Directorate of Education will be final and binding upon the player and coach.
2. The Directorate of Education, GNCT Delhi reserves the right to change/alter withdraw any/ all terms and conditions of the scheme.
3. If at any stage, a sportsperson receiving the assistance from the Government, is found guilty of age fraud or indulged in doping or getting the assistance from any other state/UT, then the assistance will be stopped with immediate effect. Recoveries will also be made of the assistance already provided.



4. The beneficiaries under the "Pandit Deendayal Upadhyay National Welfare Fund for Sportspersons", a welfare scheme for outstanding sportspersons of the Ministry of Youth Affairs and Sports Government of India, will not be barred from this scheme. But the benefits being taken by an outstanding sportsperson in the said scheme or from any other scheme of Government of NCT of Delhi will be adjusted/taken into consideration before releasing any assistance under the present scheme of Government of NCT of Delhi.
5. Sportspersons applying for assistance from this scheme will furnish information about assistance received in kind or cash from any other source for the same purpose.
6. The Directorate will devise a grievance redressal mechanism with the approval of concerned Minister of Education & Sports.
11. Accordingly, desirous sportspersons may submit their applications for Training Support (as per explanation under Criteria for Selection) and Achievement Recognition for the tournaments/championships organized in the financial year 2024-25 i.e. tournament held on or after 01.04.2024 through ONLINE module only on website <https://edudel.nic.in/edu/sportsnew.html>
