ORDER

Cancellation of Candidature and Appointment to the post of PGT (Punjabi) Female under Post Code 31/22.

Whereas, **Ms. Harpreet Kaur**, (D.O.B. 21.04.1993) (Roll No. 131301600088) has been nominated by the DSSSB for the post of PGT (Punjabi) Female, Post Code 31/22 vide letter No. F.1(607)/P&P/DSSSB/2021/1351 dated 15/01/2024 vide Result Notice No.1517 dated 26.12.2023.


And whereas, **Ms. Harpreet Kaur (Employee ID - 20251168)** has been issued appointment order with the direction to report latest by 07/01/2026 but she did not join/report her respective place of posting i.e., Tagore Garden No. 2, SKV-1515025.

Further, an extension was accorded to **Ms. Harpreet Kaur, EMP. ID 20251168** for the post of PGT Punjabi (Female) under post code-31/22 vide this order DE-2(98)/DRC (E-II)/PGT (Misc. Posts)/F/M/2023/15 dated 20/01/2026 upto 07/04/2026 failing which her candidature shall stand cancelled without any further communication. But the candidate did not join her place of posting.

After that **Final Notice for joining** of even No. 281 dated 06/05/2026 was issued to her with the direction to join her place of posting within 10 days from the date of issue of final notice for joining but she did not join her duty in the respective place of posting on said scheduled date and time.

Therefore, in view of the above facts and circumstances the **appointment and candidature in respect of Ms. Harpreet Kaur (Employee ID- 20251168)** for the post of PGT Punjabi (Female), Post Code-31/22 is hereby **cancelled**.


