




Consequent upon selection through Delhi Subordinate Services Selection Board to the post of PGT ECONOMICS (Female), vide supplementary Result No. 77, Dated. 24.03.2025 and in compliance of Ld. CAT order dated. 26/07/2024 in O. A. No. 2836/2015 and C.P. No. 869/2024, in the matter of Ms. Shabana Parveen Vs. Govt. of NCT of Delhi & Ors. , with the Prior approval of the Competent Authority, the candidate is hereby appointed on Provisional basis to the post of PGT ECONOMICS (Female) vide post code 32/2010 in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4800 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by him/her, In case of OBC/EWS candidate the appointment will be provisional at the time of joining the candidate will have to submit an undertaking to concerned Head of the School/office that "It is hereby undertaken that the information furnished by me is true and correct and the OBC/EWS certificate is as per provisions contained in DSSSB advertisement number 02/2010 and in the event of being found false or detected incorrect or incomplete at any stage or any ineligibility being detected after the appointment, my candidature / appointment is liable to be cancelled / terminated automatically without any notice and action can be taken against me by the department as per Rules". Subsequently, the OBC/EWS verification report will be checked by the DDE concerned. If the OBC/EWS certificate of the candidate concerned is found invalid, his/her candidature will be terminated with immediate effect. The candidate(s) is/are hereby directed to report to their respective place of posting latest by 25/09/2025, failing which his/her appointment shall stand cancelled without any further communication.
